

Whatcom County EMS System OTEP (Ongoing Training & Evaluation Program) 2025-2027

Revised 10/24

Overview

All Whatcom County Emergency Medical Service (EMS) agencies agree to implement the Ongoing Training and Evaluation Program (OTEP) model as outlined within this document. Oversight of this implementation is the responsibility of the Whatcom County EMS and Trauma Care Council (WCEMS-TCC), Department Supervising Physicians, and Whatcom County Medical Program Director (MPD).

All providers will be required to meet didactic and skill requirements listed in WAC 246-976-161, per certification cycle.

BLS Providers (EMR and EMT)

- Each quarter will consist of didactic lessons delivered through EMS Connect online and other local content as directed by the MPD.
- Psychomotor evaluations will be provided onsite by Whatcom County/Washington State DOHapproved EMS Evaluators (ESEs).

ILS Providers (AEMT)

- Each quarter will consist of didactic lessons delivered through EMS Connect online and other local content as directed by the MPD.
- Providers will receive onsite practical skills, and individual agencies will provide evaluations through Supervising Physicians or their approved delegate. Practical scenarios and skills performance criteria will be provided through the WCEMS-TCC to ensure standardized content and consistent instruction throughout the county.
- Personnel will hold certification in AMLS, PHTLS, PALS and/or PEPP, ACLS, and HCP BLS, as available
 through the American Heart Association, American Academy of Pediatrics, National Association of
 EMT's or other agency offering such education, during their recertification cycle regardless of
 certification expiration.

ALS Providers (Paramedic)

- Monthly didactic lessons will be delivered through in-person Medic CE at the ALS agencies. The
 content covered will include the topic from the previous month's EMS Connect assignment. In
 addition to the assigned topic, Supervising Physicians may select additional topics or use designated
 subject-matter experts to present special cases and events.
- On-site practical skills and evaluations will be provided by Supervising Physicians on an annual basis during a Medic CE. Skill evaluations will meet the requirements of WAC 246-976-161.

Run review and feedback to EMS responders will be provided through the Image Trend reporting platform by the MPD, Supervising Physicians, or other individuals qualified and designated to manage quality assurance and improvement at individual agencies.

<u>Curriculum, Evaluation, and Documentation</u>

In-person and online lesson content and objectives will be designed to fulfill the requirements listed in WAC 246-976-026 and WAC 246-976-161. Washington State Department of Health's *Education Requirements for the Recertification of EMS Personnel and OTEP Development* document (DOH 530-234, April 2019) will be used for reference.

Whatcom County EMS Agencies will use the most current version of Washington State Department of Health practical evaluation skills sheets or sheets approved by the WCEMS-TCC and County MPD. The Washington State DOH Practical Evaluation Skill Sheets can be found at https://www.doh.wa.gov/Portals/1/Documents/Pubs/530226.pdf.

Each individual EMS agency will cover Infectious Disease and Multicultural Health and Equity training and education once per recertification cycle per provider.

Each individual EMS agency will cover Local Policy and Protocol training and education once per recertification cycle per provider. Policy training will also cover regional Patient Care Procedures (PCPS) and County Operating Procedures (COPS), if applicable. Protocol education will include the scope of practice and EMS certification requirements. If any protocol changes occur after the initial protocol review, then each agency will additionally cover those updates.

Following each online didactic lesson, providers will complete a cognitive evaluation of the lesson material with a minimum passing score of 80%.

Practical application scenarios and skills evaluation may only be delivered after a provider has successfully completed the online didactic quarterly training.

Individual evaluation scores will be recorded on an approved tracking form in either paper or electronic form, in accordance with WAC 246-976-026.

Skill Maintenance - Airway Management and Vascular Access

Per WAC 246-976-161, skill maintenance is a required component for both OTEP and CME methods of recertification under WAC 246-976-162 and 246-976-163.

All providers, EMR, EMT, AEMT, and Paramedic, must demonstrate the ability to perform a skill properly to the satisfaction of the MPD or approved MPD delegate. Skill proficiency must include opportunities for EMS providers to annually practice, demonstrate proficiency, and document skills listed in WAC 246-976-161.

Quality Improvement

WCEMS-TCC and Whatcom County EMS (WCEMS) will monitor instructors and provide ESE workshops to ensure quality instruction and evaluation of OTEP participants. In addition, the MPD or WCEMS Training Coordinator will periodically audit training sessions.

Feedback from quarterly Continuing Quality Improvement (CQI) committee meetings will also be used to identify system training or performance strengths and weaknesses.

Each individual EMS agency, the MPD, and WCEMS will monitor EMS provider progress and compliance with OTEP requirements and work together with participating agencies to identify and correct training discrepancies.

Remediation Plan

Any provider failing a practical scenario or skills station will be provided with two (2) additional attempts to complete the scenario or skill successfully. Remediation will be provided between unsuccessful attempts at any scenario or skill.

If a provider fails three (3) successive attempts to perform a scenario or skill, then the provider will receive further didactic instruction. All failures, remediation, and subsequent passing of a skill or scenario will be documented by the responsible home agency and remain with the EMS training record of the individual provider.

All providers shall complete didactic and psychomotor sessions within the quarter they are assigned. In the case a provider misses or fails to complete a didactic or psychomotor session within the assigned quarter, then the didactic module or skill session must be made up within the following quarter that it was assigned. A provider will be moved from OTEP model to the traditional method of recertification if they fail to meet the requirements listed in the OTEP plan.

If a provider is absent from duty for an extended period due to illness, injury, leave of absence, or other extenuating circumstances, the EMS agency will remove that provider from providing patient care and provide the individual with a remediation plan that will be administered by the affiliated EMS agency's training officer and be approved by the MPD. Remediation plans for such absences will include any topics that were missed by a provider on leave and skills competency verification on any missed topics. After successful remediation, the affiliated EMS agency's training officer will place the provider back onto the OTEP plan. As a last resort for remediation, a responder may be placed on the traditional method of recertification.

Any provider requiring military leave will contact the Washington State DOH to be placed into "military" status prior to deployment or upon activation. This provides specific benefits and protections. For more information: Military Resources - Frequently Asked Questions | Washington State Department of Health.

Personnel Transfer

When an EMS provider transfers affiliation from another county to a Whatcom County agency, they will be required to provide the affiliate agency with documentation of all EMS continuing education they have completed for their current certification cycle. The MPD will assign any make-up or remediation needed prior to placing the provider on the Whatcom County EMS System OTEP Plan. If a provider is significantly deficient of acceptable continuing education requirements the provider may be placed on the traditional method of recertification for that recertification cycle. All new providers will be expected to prove competency and acknowledge receipt of the Whatcom County EMS System Protocols. Providers are required to meet all requirements listed in WAC 246-976-161.

Recertification and Documentation (Department and County Responsibilities)

Agency training officers, WCEMS-TCC, and the MPD are responsible for final review of all recertification materials for affiliated providers. All documentation for recertification will be forwarded to the WCEMS-TCC office for processing. WCEMS-TCC will perform a records verification of each provider prior to recertification to ensure consistency with WAC 246-976-161, WAC 246-976-163, and WAC 246-976-171 before approving the provider's application.

Agencies will maintain training records for a minimum of seven years or in accordance with the records retention requirements of the organization, whichever is greater. Also, agencies will provide training records to participants, the department and MPD upon request. This includes skill sheets, rosters, evaluations, quizzes, and training content.

In the event that the traditional method of recertification will be used, it will be consistent with WAC 246-976-161, WAC 246-976-162, and WAC 246-976-171.

Recertification and Documentation (Provider Responsibilities)

Individual EMS providers are responsible for reviewing and maintaining records for their certification period. Per WAC 246-976-161 (2), the EMS provider shall maintain records of successfully completed educational, practical skill evaluation and skill maintenance requirements for a minimum of seven years. The EMS provider shall provide records to their EMS agency, their county medical program director, and the department upon request.
