**REPORTS:**

**North Region:** next meeting will be October 3<sup>rd</sup>.

**Funding:**

The council would like to purchase Manikins for training in the districts.  
They must at minimum have airway and defib  
Will ask for @ \$10,000 matching funds for 4 basic manikins, one for each region.  
The council will buy two and ask for two. Duncan will research price.

Discussing with Julie @ BTC about donating ambulance to BTC and have them maintain it for use with EMT and paramedic program.

**Training Officers Report:**

Recruit academy is going with 40-45 people.  
The Training officers want a voice with new OTEP.  
Will find a rep from training officers and get them onboard.

BFD may go with RMI for 2020.

Dr. Wayne mentioned that the quality of 24/7 EMS is improving and asked if the council was looking into that for OTEP  
EMSCoconnect will be looked at this month.

**CQI:**

The next CQI meeting will be at the end of September.  
Hilley met with Rachel Lucy and Susie Johnson about Health information exchange.  
\$10,000 for health information exchange

Still have dirty equipment in ED.

Trauma CQI meeting: A critical patient was picked up at nursing home and dropped off at the hospital. The family was not contacted; the patient died and the family never knew until the next day.

Remind crew to please ask/remind the nursing home to notify the family as they are leaving the nursing home.

Need to put ALL medication into ImageTrend no matter who gave it to them. (e.g. police administered NARCAN)

**Hospital:**

Andrea will ask Becky for info for Education meetings.

Dr. Wayne brought up the need to for hospital to get serious about active shooter events.

Most patients will show up in private vehicles

Dr. Wayne met with Catie Holstein @ DOH about community paramedic. WAC will be changing. Community paramedic is not defined. State doesn't recognize that specialization.

**Old Business:**

BLS Evaluator workshop will be held on November 2<sup>nd</sup>. There will be a 12 person limit.

ASHI train-the- trainer course had 9 students.

**New Business**

Travis Alert Act- the Curriculum and PowerPoint is on the council website. Agencies will keep their own training records. The PowerPoint will be put on ImageTrend.

BLS Protocols- Each district is responsible to document that the protocols were distributed.

The wording for this will be changed in protocols.

There will not be CPAP in the protocols until training is done.

EMT courses should teach basics of CPAP

Education -Training coordinator position needs to be approved by council by October 15<sup>th</sup>.

TAB and EOB meeting is in Sept. Need to put \$ amount into next year's budget.

\$60,000-\$70,000 plus benefits packages. Make proposal to hire full time person.
