CPR pregnancy: AHA update for pregnant patients it is recommended to move fetus off to side. LUD -Lateral Uterus Displacement. Moves fetus to left and remove off of inferior vena cava to improve blood flow.

Dr. Wayne suggests teaching it. Will add into protocols at some point.

Good of the order:

Need a better referral method for community paramedic option than just hitting a button. Need to make a requirement such as a contact number from person referring and some type of narrative.
