REPORTS:

North Region:

- Next meeting is on November 4th.
- MPD's had a regional meeting and discussed destinations of patients.

Funding:

- North Region Grant Applications are due October 25th.

Training Officers:

Unfinished Business:

- WCEMS should put video on RH to be available for all providers.
