## Seller Agreements

It can take some time for your new puppy to adjust. We have noticed it is usually not more than a day, but remember this is a new environment for your puppy so they may not eat or socialize at first.
- 2. The pedigree furnished is correct.

- 5. ABKC Registration papers will be filled out after the sale is complete, and will be forwarded to the buyer once the ABKC returns them. **\*\*\*\*usually at time of pick up**
- The registration is \_\_\_\_\_\_. Puppies sold on limited registration may not be shown in ABKC conformation shows or bred. The buyer's understanding and acceptance of this condition are signified here by his/her initials: \_\_\_\_\_\_on
- 7. The seller guarantees this puppy/dog is of sound health. A health record of shots and/or worming will be provided by the seller. The purchase price of this puppy/dog will be refunded if the buyer furnishes the seller with a veterinary certificate indicating that the puppy/dog is unwell or unsound within 72 business hours of purchase . The Seller will reimburse no veterinary or shipping costs. If the puppy is not seen within 72 business hours of purchase no refunds will be given.
  - The puppy has had it's first round of shots and has been dewormed and vet checked. Please bring a copy of shots/deworming with you to your vet. A puppy can become very sick if the vet doubts our records and doubles up

on any medication. We will not be held responsible if your vet chooses to do so.

- We do not use leptospirosis in our shots. This is due to allergic reactions. Please make your vet aware so they can administer the right dosage.
- Do not take your puppy anywhere until their shot regimen is finished. You risk Parvo and many other illnesses if you do. Grass can be contaminated along with the floor of inside facilities. The vet's office can be the most contaminated. We will not be held responsible if you do not follow this instruction.
- We do not warrant against Hypoglycemia, Molera, Luxating Patellas, Collapsing Trachea, cherry eye, hernias, skin conditions, cryptorchidism (retained testicles), size /weight, ears, teeth/bite, temperament or coat color/texture/length.
- We do not warrant against Coccidia or Giardia or the presence of worms. We have done the appropriate deworming schedule, but a puppy should still be dewormed again every two weeks until twelve weeks of age, then monthly until six months of age. Many puppies are prone to an outbreak of Coccidia and/or Giardia under stressful situations. The symptoms can start as soon as 12 hours after a puppy leaves, and can not always be prevented by the seller, because there are no signs until the puppy/dog is stressed, and their immune system drops.
- This portion is sensitive. Although we understand a puppy can never be replaced this is a health guarantee for new owners. If a hereditary defect develops by 1 years old that is life threatening or requires life long care we will be notified immediately and emailed a copy of the diagnosis from a licensed veterinarian. Buyer is to return the puppy along with all original paperwork and updated paperwork within one week from diagnosis. Seller will replace the puppy with another puppy of the same sex/equal value when a puppy becomes available again. If the buyer decides to keep their puppy, the seller is not responsible for any medical cost that will occur. In the case the puppy has passed a photo must be sent along with a necropsy report from a licensed veterinarian. If it is found the puppy of same sex/value when one is available. If your pup was not taken to a licensed vet by 10 weeks of age then no replacement pup will be given.
- 8. If the buyer has paid by check, the purchase price will be refunded only if or when the buyer's check has cleared and been credited to the seller's account.

- 9.The Buyer agrees to provide a life-long commitment, comfortable environment, prompt. medical attention, proper grooming and responsible care. This includes keeping this puppy/dog parasite free and up-to-date with vaccinations, proper nutrition, which consists of a good quality professional feed (we recommend Four health puppy and Taste of the Wild Ancient Grains) given at regular intervals, and fresh water available at all times. The Buyer promises to provide a safe environment for the dog, and never allow the dog to roam freely without proper fencing or supervision.
- 10. The puppy/dog is healthy at the time of sale and has had immunizations enumerated in the attached health record.

11. At any time the buyer is unable to keep or care for the puppy/dog, it must be returned to the seller. The puppy/dog may not be transferred or sold by the buyer. The buyer's understanding and acceptance of this condition is signified here by his or her initials:

The seller will endeavor to place any returned puppy/dog as advantageously as possible. If a purchase price is obtained for the puppy/dog, it will be refunded to the original buyer, less any costs of placement. If the puppy/dog is placed free of charge, no money will be returned to the original buyer. No veterinary or other costs of keeping the puppy/dog, or any other costs incurred by the buyer resulting from his/her ownership of the puppy/dog, will be paid by the seller to the original buyer of the puppy/dog under any circumstances.

- 12. The seller in no way guarantees that this puppy/dog shall win in conformation and/or performance events.
- 13. The seller agrees to provide advice and information on showing and grooming to the best of his/her ability, to help the buyer of a show or performance potential puppy/dog to present the canine to its best potential.
- 14. If the seller determines, by any means, that the puppy/dog is not suitably cared for, or that it has been mentally or physically mistreated, the seller has the right to take full possession of the dog, and its duly signed ABKC transfer papers/registration, without compensation. The seller's opinion is the only authority required to justify this action. Testimony of other people will not supersede the seller's judgment on this matter. Under such circumstances, all

warranties are then VOID.
