

STUD SERVICE AGREEMENT

Stud is American Kennel Club (AKC) registered. Registration with any organization other than AKC must be approved by breeder. If dual registration is desired, dam's owner is responsible for registration fees for both dam and stud.

**** If Dam *is* AKC registered, INCLUDE a copy of her AKC registration with this agreement:**

Half of the stud service fee due plus full shipping fees must be paid prior to shipment or insemination. The remaining balance of the stud service fee is due before puppies are 6 weeks old.

**** If Dam *is not* AKC registered or you do not submit a certified copy of her AKC registration prior to stud service:**

Full payment of the stud service fee and shipping fees must be made prior to shipment or insemination.

On-site stud service at our location is provided through artificial insemination ONLY. Procedure will be provided by the stud's owner at no additional charge. If a licensed veterinarian is preferred, it will be at the additional expense of the dam's owner (not included in the stud service fee), and must be arranged and paid for directly by the dam's owner.

For shipment of semen, there is an additional \$175.00 shipping charge for each overnight shipment (add \$25 for Friday shipment- shipping companies charge extra for Sat delivery.) Please note that if the shipping company does not deliver your package by the delivery commitment time and/or date, there is a possibility that you will not be reimbursed for the shipping charge. Both Fedex and UPS have certain conditions that need to be met for a refund. Each shipment will contain an amount of semen for one insemination to one dam only. Semen is sent chilled in an insulated box & container. Box and contents must be returned to breeder (pre-paid postage label provided.)

Shipping customers: payments accepted through Paypal. Paypal account should be in the customer's name. If not, the Paypal sender must also sign this agreement. Payment must clear prior to shipment. We recommend that you make Paypal payments the day before shipment- we will not accept "pending payments."

On-site customers: payment must be made in cash.

Stud service fee applies to insemination of one dam only.

Recommendation: Have progesterone tests done on the dam. The most important factor in a successful artificial insemination is the proper timing of the insemination. Inquire with your vet.

If the dam does not conceive, additional breeding to the same dam may be provided, **however you must contact the breeder between 50-55 days after first insemination to qualify for the additional breeding.** If approved, a free (no additional stud service fee) 2nd breeding to the same dam will be provided. If the 2nd breeding is unsuccessful in producing a pregnancy, a free 3rd and final breeding will be provided. If the 3rd breeding is unsuccessful in producing a pregnancy, no additional breeding will be provided. The original stud service fee and all shipping fees are non-refundable. Dam's owner will be responsible for any and all veterinary, traveling and/or shipping expenses for the 1st, 2nd and 3rd breeding.
