RELEASE, HOLD HARMLESS & INDEMNIFICATION**

Valholler Farms Hunting Club, LLC.

In exchange for limited guest access on the lands and facilities managed by Valholler Farms Hunting Club, LLC. (hereafter referred to as "Club"), located at 1053 Brinson Cemetery Road Swainsboro, GA 30401 the Participant agrees to the following:

Participant waives for his or her executors, administrators, assignees or heirs, any and all rights and claims for damages, losses, demands and any other actions whatsoever, which he or she, individually or in solido, may have or which may arise against "Club", and any of its heirs, employees, directors, officers, landowners or agents, including but not limited to any and all injuries, damages or illnesses suffered by Participant, Participant's family, Participants guests and/or Participant's property, which may, in any way whatsoever, arise out of, be related to, but not limited to, or be connected with hunting or in any way connected with his or her presence on the property of "Club". Participant on behalf of himself or herself and his or her executors, administrators, assignees or heirs, hereby expressly release "Club" and any of its heirs, employees, directors, officers, landowners or agents from any and all such claims.

Participant hereby expressly assumes the risk of entering the land of "Club" and of taking part in activities relating to hunting, fishing or any activities on the land of "Club" which include, but are not limited to, the discharge of firearms and the firing of live ammunition and use of and presence on the land of "Club".

Participant agrees to indemnify, hold harmless and defend "Club" and any of its heirs, employees, directors, officers, landowners or agents from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to, but not limited to, or connected with the discharge of firearms, use of and presence on land of the "Club". And should any such claim, demand or lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws of the United States, any state, or under any theory of law or equity, Participant will indemnify, hold harmless and defend "Club" and any of its heirs, employees, directors, officers, landowners or agents, from any and all costs, expenses or liability including, but not limited to, the cost of any settlement or judgment made or rendered against "Club" and any of its heirs, employees, directors, officers, landowners or agents, whether individually, jointly, or in solido with Participant, together with all costs of court and other costs or expenses incurred in connection with any such claim, demand or lawsuit, including attorney's fees.
