### **ADDITIONAL VENDOR INFORMATION**

1. This event will be held rain or shine. This is an outdoor event with possible uneven terrain, inclement weather and wind gusts. Please bring weights and or screws and drills for your canopy
2. Your booth must be open and staffed during all hours of the event . Hours are usually 10am to 6pm.
3. You are responsible for keeping your booth and area clean at all times.
4. **Sales Tax** - You will need to collect sales per Nevada Administrative Code If you are selling at Round Hill. You will need to obtain your own sellers tax permit. You can apply online. If you are selling at Middle School in So Lake Tahoe you will need a CA sales tax permit.
5. **CITY OF SOUTH LAKE TAHOE REQUIRES** all vendors to have a City of SLT business license. You can purchase it at the show IF YOU DID NOT DO SHOWS LAST YEAR. It cost around \$45 and is good for the summer season. For returning vendors, you are required to obtain a year round license. You can apply online on the City Of South Lake Tahoe website. [www.cityofslt.us](http://www.cityofslt.us) Go to the "HOW DO I" section. Click on "apply for a business license. The base fee for yearly is \$68.
6. If your product requires water, you must bring your own.
7. **BOOTH SPACES** are in 10 x10' increments, 10 x20', and a few 10 x 15. No electricity NO generators You must have your own set-up. You must provide your own tables and display. Booths must look clean and professional. Tables must have table covers.
8. **PARKING** for vendors is in a designated area. If you don't know where to park, Check with the show manager for details.
9. All sales are from your assigned booth. No roaming sales.
10. Pets/animals of any type are not permitted, other than service dogs.
11. **ENVELOPES WILL BE PASSED OUT** at the end of the show to collect the 10% commission. Turn in your envelope with monies before you start tearing down your booth.
12. No bullhorns or megaphones, flashing lights or strobes, speakers or sound amplification is allowed.

### **LOAD IN/LOAD OUT PROCEDURES**

There is no overnight security provided for booths. So, if you are worried about theft, please take your product with you.

Overnight camping is not allowed in the City of South Lake Tahoe except for security vehicles.

There are some campgrounds in the area: Campground by the Lake, Tahoe Valley, Chris Haven, Camp Richardson and Nevada Beach Campground.

**SHOW SET-UP TIMES:** Vendors can set up the night before the show after 5pm, or the morning of the show after 7am, unless otherwise directed. At the end of the show, you are required to clean up your area, including zip-ties and labels.
