## RULES OF DISTRICT OF CHAPMAN BEACH

THE FOLLOWING RULES ARE INTENDED TO ELICIT COOPERATIVE PRACTICES AND BEHAVIOR FOR THE SAFETY, ENJOYMENT AND WELL BEING OF DISTRICT RESIDENTS, GUESTS, AND TENANTS.

#### 1. General Policies:

- a) No rubbish, building materials, garbage, leaves, or brush shall be left on District property.
- d) Dogs must be leashed at all times and pet owners are responsible for prompt disposal of animal waste.
- e) Reasonable quiet must be observed from 10 pm until 7am.

## 2. Roadways and Parking:

a) No parking on any roads or right of ways owned by the District. Speed Limit on all roads is 20 miles per hour.

# 3. Boating: Document applies to all types of watercraft, including but not limited to kayaks, canoes, sailboats, motor boats, and paddle boards.

- a) Watercraft should never be within the designated swim area.
- b) Kayaks and paddle boards must be stowed in the racks. No boats are allowed west of 2nd Avenue Beach.
- c) All watercraft on the beach must be registered and labeled. Refer to ChapmanBeach.org for instructions.
- d) For safety, boats may only be brought to the beach before 11 am or after 4 pm.
- e) All watercraft must be removed for the winter by November 15 up to Memorial Day weekend.

#### 4. Beach:

- a) **Beach pass is required on beach and beach pass placard must be displayed.** If multiple beachgoers are in attendance at least one placard needs to be displayed.
- b) GLASS OF ANY TYPE IS STRICTLY PROHIBITED from the beach and common areas.
- c) No dogs are allowed on beaches between 9 a.m. and 6 p.m. from Memorial Day weekend thru Labor Day.
- d) Diving from any jetty is prohibited.
- e) All beachgoers are required to clean up their area of use before leaving the beach at the end of the day, taking all belongings with them, including chairs, tents, umbrellas, etc. Deposit trash in available trash receptacles.
- f) Cigarette and cigar butts shall be disposed of properly and not in the beach, sand, or water.
- g) Volatile fuels and fires are not allowed on the beach

### 5. Use of District Property:

The following private events held on district beach property require a minimum 14 day prior approval by BOD and may require proof of insurance:

- Professionally organized private events (i.e. weddings)
- Musical performances/Professional entertainment
- Commercial/Vendor organized gatherings

#### 6. Solicitation:

No private person or group is permitted to sell or solicit any items on any district property.

#### 7. District Conduct:

Our goal to conduct District Meetings in an effective, efficient, and civil manner.
