#### Clerk's Report

 Motion made by Andy Calderoni to accept minutes from 10/21/13 BOD meeting taken by Patrice Horan. Motion seconded by Pete Potter and carried unanimously.

#### **Treasurer's Report**

- \$49,252 in checking accounts.
- Surplus this year due to unused legal fund.
- We are paying insurance only on common property and beaches. This will result in a decrease of our insurance premium.
- Motion made by Eloise Kumnick to accept clerk's report. Seconded by Damian Ranelli. Motion carried unanimously.

## **OLD BUSINESS**

## **Seawall Repair**

 Motion made by Tom ODell to pay "All Habitat" \$937.38 above the signed "not to exceed" fee of contracted amount. Motion was seconded by Pete Potter.

- Discussion of Motion taken from email account:
- Pete Potter asked Tom ODell to get an itemized list of All Habitat's fees.
- Tom ODell to get a breakdown of fees leading to the extra \$947.38.
- Tom ODell explained that David of All Habitat will continue to assist the District in establishing vegetation on the upland portion of the beach, recognizing it may take several growing seasons for this to happen.
- Tom ODell stated that the majority of the overage (\$810.00) was for a truck load of sand needed to mix with dirt to spread on top of the sand filled soxx.
- Tom ODell: they could have asked for add-on when they needed the load of sand but that would have held up the project till approval was received from the district.
- Tom ODell: heat and lack of rain prohibited the grass from sprouting.
- Tom ODell: the use of all Habitat's soft structure instead of a hard structure saved the district significant time and money.
- Damian Ranelli to ask All Habitat if they would like to meet us halfway on the bill. He said it is not customary to go above and beyond a not to exceed contract without speaking to the client first.
- **Results of motion:** Five voted not to pay extra \$947.38. Three voted to pay the overage. Andy Calderoni remained neutral on the vote due to there not being a tie. Motion did not pass.
- Railing is up.
- Need to get vegetation established, particularly south of railing.
- Hallohan will do concrete work when temperature gets warmer or beginning of March to put in ramp, stairs and walkway.

- Andy Calderoni said that Vintage Storing Car is located on Route 1.
- Vista residents are interested in lot on Route 1 property.
