 - 5. I'm writing to express my concern regarding the placement of the porta potty in our Chapman Beach community. While I understand the potential intent behind its presence, I believe it is unnecessary and negatively impacts our neighborhood for several reasons. First, the heat and humidity typical of beach areas significantly intensify odors from the unit, making it unpleasant for nearby residents. Additionally, Chapman Beach is a private community, and residents have access to their own homes should facilities be needed, eliminating the need for a public restroom on-site. Moreover, the porta potty is visually unappealing, detracting from the aesthetic of our otherwise beautiful and well-maintained beach environment. Maintaining the charm and cleanliness of our neighborhood is important not only to homeowners but also to guests who visit and respect the space.
