

Hi all, we at

Campsie Community Council (CCC) want to keep you updated on the following:-

The River Glazert Restoration Update & Lennox Castle information to date .

Campsie Community Council managed to set up the sub group CRAAFT due to the amount of concern that was raised by the community, and, the concerns that the community had.

We informed about & encouraged people to attend the consultations as individuals to raise their concerns. In addition, the Community Council had requested to have a community consultation, this went ahead with more than 100 people attending.

At this consultation the CCC asked for in-depth information from the applicant and we also aske to look at different locations.

At the end of the pre-planning stage, the CCC had to give response to planning, this response was made up of 2 responses; the Community Council & the CRAFFT sub group.

We also had walk arounds with the CBEC, SEPA and EDC In addition, we also had a walk around with an EDC planning officer.

The next stage was the official application, the council ha made some concessions. In reach 2- the CCC had also spoken to other consul-tees to the application, this was to ask questions on their responses that were conflicting to the application, and, their purpose as government bodies

We have had meetings with MP's MSP's and Scottish Ministers., relating to which, we are still awaiting one response coming back, this is in regards to the Scottish Government policy - on the removal of the ancient



woodland policy - that is not recognised within the planning policy on which the application has been granted permission.

We also had a meeting with a high level tabloid reporter who also had concerns as well as an interest in the application, this was due to their connection to the village and they felt that they had a good enough story to raise awareness as to what was being proposed.

This made the front page of a National Tabloid, and we, as a group, were very grateful for this input and spreading of

We, the CCC have always looked for middle ground with the applicant, in order to keep a good working relationship that is expected from the Community Council. That being a Community Councils purpose.

The CCC would also like to inform, as mentioned above, that in our official response to the planning application, that it was inclusive of 2 responses from the Community Council and CRAAFT. It was very detailed, as well as us asking to make representation in person to the councillors of the planning committee, unfortunately, it was not taken into consideration by the planning department.

We got notification that the planning department had made recommendations that it be passed, and that this would be presented to Councillors to vote on.

The CCC had no other option but to raise concerns with the NHS who owns the land to request an asset transfer, this was not to frustrate the applicant, but in order to protect an area of land that has major historical value to the village, it is an area of tourism, it is protected under ancient woodland and it is also a conservation area. This is an area that the community cherish dearly. This is also something that the Community Council has done to encourage in the area, and make the area better, as well as protect the areas mentioned above.

The CCC are still in talks with the NHS in regards to this land, and, hopefully at the meeting in the near future, being proposed by the NHS that we will have a conclusion or an opportunity for further discussion with the applicant.

We have also been given permission from the NHS to use the Garlic Wood for a light show and a story telling event being held in early October.

Please be assured that the CCC and Sub group CRAAFT have spend numerous amounts of hours at meetings, giver up a vast amount of time to work on this application, and made more sacrifices in family life over the last year and a half to continue to try to seek middle ground and represent the communities concerns.

LENNOX CASTLE

During the River Restoration project application, the question was asked;

Was the application to help housing? to which we were told no .

The CCC's chair Stuart Carr has exhausted and went to all lengths to look into this with Mack & Mick Homes and the NHS, there is no connection to the River Restoration.

If the NHS refuse the River Restoration, then, it is not going to make a difference to the planned housing developments being proposed. They will still go for full planning application to the planning board, just to be clear, it is not the Community Council who pass the planning applications.

The Land has consistently been on EDC housing development plans since it was classed as a brownfield since the Tri Part agreement between NHS, EDC and Lennoxtown Initiative.

Before planning came up, we had been helping the Nadora Project find out about the castle and their proposal for partial refurbishment of the Castle and a part of the land. This started back at the end of 2023 but we had been discussing with EDC before 2023.

The CCC were looking at using the land for community use

So with the pre application going in, we have spoken to the NHS and Mack & Mick .

We have decided that currently there is no point in talking, however, we are going to have a meeting, this will be before the pre-planning stage is completed, this is so that we can raise the issues that is felt is relevant for the areas of concern, there are a few to work with so far. It is also our duty to make sure that there is community benefit in addition that land receipts are reinvested in Lennoxtown and the surrounding areas.

This was always the goal of the original agreement, it

This was always the goal of the original agreement, it would be very foolish and reckless of the CCC not to look at seeking community benefit so Lennoxtown can become a better place.

We also have interest in areas of land currently just now, and, separately from the River Restoration, the CCC have been invited to discuss about the possibility of working in partnership with the NHS and the Nadora Project for the walled garden and other areas of land.

We don't know if all the land is going to be built on and once the land surveys are complete it will then give a better idea as to how much land will be used for housing. This information, we will find out before the end of October.

So please do not think we are not being active or that we are not representing Lennoxtown, Haughhead and Campsic Glen as evidenced by this post, we are working harder than ever to achieve greater goals for the village.

We have events coming up soon and have been provided maps by EDC to work on what people want to see in the areas and we, as always, will welcome everyone's input.

Everyone has a voice and everyone is entitled to representation. We need more input from our communities and we need to know your concerns in order to help our ward councillors and EDC recognise our Communities Priorities.
