The IRS continues to be understaffed and many employees lack experience. The IRS technology and computer systems are improving albeit slowly. Backlogs of unprocessed returns continues to hamper operations and taxpayer communication.

There are 3 ways to exchange information with us:

- 1) In person at our office
- 2) By email from our website file transfer system. (More info on our web site)
- 3) By regular mail (USPS) We do a lot of work by mail, and while not the most convenient, it can work pretty well.

Please remember we have Convenient Parking for our clients on the north side of our building, the "Old Town Center" in Wichita's Historic "Old Town". Our office is on the 2nd floor, northeast corner of First (one way east) and Mead, just east of the main downtown railroad tracks. The entrance to our building is on Mead street.

Our scheduled tax season office hours will be:
