The Petition to Confirm Arbitration Award filed by Petitioner Plastic Nation Media Rights, LLC ("PNMR") came on regularly for hearing on March 12, 2018 at 8:30 a.m., in Department 20 of the above-entitled Court, the Honorable Dalila C. Lyons presiding. After consideration of the arguments of counsel and all pleadings and papers, and proof having been made to the satisfaction of the Court that the Petition should be granted.

IT IS HEREBY ADJUDGED, ORDERED AND DECREED THAT judgment shall be entered in favor of PNMR and against Respondent Sycamore Entertainment Group Inc. ("SEGI") pursuant to the Arbitrator's award of January 10, 2018. Judgment shall be entered as follows:

1. PNMR is entitled to damages in the amount of \$511,852.07 (\$550,000.00 less SEGI's \$50,000.00 partial capital contribution, plus SEGI's unpaid JAMS

 Sycamore Entertainment Group, Inc. is in breach of Operating Agreement II because it did not meet its payment obligations; and

arbitration costs and fees in the amount of \$11,852.07);

 As a result of failing to meet its payment obligations, Sycamore Entertainment Group, Inc. is not a member of PNMR.

Furthermore, PNMR is entitled to post-judgment interest at the rate of 10% per annum until the judgment is paid (California Civil Code § 3287 and California Code of Civil Procedure § 685.010(a)). The clerk is ordered to enter the judgment forthwith.
