




1 The Petition to Confirm Arbitration Award filed by Petitioner Plastic Nation Media Rights,
2 LLC ("PNMR") came on regularly for hearing on March 12, 2018 at 8:30 a.m., in Department 20
3 of the above-entitled Court, the Honorable Dalila C. Lyons presiding. After consideration of the
4 arguments of counsel and all pleadings and papers, and proof having been made to the satisfaction
5 of the Court that the Petition should be granted.

6 IT IS HEREBY ADJUDGED, ORDERED AND DECREED THAT judgment shall be
7 entered in favor of PNMR and against Respondent Sycamore Entertainment Group Inc. ("SEGI")
8 pursuant to the Arbitrator's award of January 10, 2018. Judgment shall be entered as follows:

- 9 1. PNMR is entitled to damages in the amount of \$511,852.07 (\$550,000.00 less
10 SEGI's \$50,000.00 partial capital contribution, plus SEGI's unpaid JAMS
11 arbitration costs and fees in the amount of \$11,852.07);
- 12 2. Sycamore Entertainment Group, Inc. is in breach of Operating Agreement II
13 because it did not meet its payment obligations; and
- 14 3. As a result of failing to meet its payment obligations, Sycamore Entertainment
15 Group, Inc. is not a member of PNMR.

16 Furthermore, PNMR is entitled to post-judgment interest at the rate of 10% per annum
17 until the judgment is paid (California Civil Code § 3287 and California Code of Civil Procedure
18 § 685.010(a)). The clerk is ordered to enter the judgment forthwith.
