



Jono's Sheep Services & Jono's Cattle Services Livestock Sale Terms & Conditions



1. The following terms and conditions govern the services provided by Jono's Sheep & Cattle Services, including livestock sales, transportation, and funds handled. By engaging our services, clients agree to comply with the following terms and conditions.
 - 1.1 Description of wording throughout this document. *We* refers to Jono's Sheep Services & Jono's Cattle Services. *You* refers to the client who acknowledges and signs the following Terms and Conditions. *Staff* refers to a person who employed by Jono's Sheep Services or Jono's Cattle Services.
2. On collection days of animals that are being transported on sale days, where extreme heat is forecast to be over 38 degrees Celsius by the Bureau of Meteorology, staff reserve the right to cancel the collection of animals due to extreme heat and to not cause animal abuse or neglect.
3. All livestock that are being sold must be transported with an NVD ear tag, any animals found to not have an NVD tag will carry additional charges as animals without NVD tags cannot be legally sold.
4. Livestock that is to be sold must have the correct NVD and Health Declaration forms filled out correctly and be valid for sale. These forms must be completed on date of animal collection as they must accompany the animals during transportation.
5. We will provide a basic, 1-time only fee of \$70, property assessment of your loading yards prior to collection of livestock, to best assess collection of animals and can provide you with an estimate that your livestock may sell for. (The estimate provided is not a guarantee of what your animals will sell for at the market, it is an estimate only.) Any other services required at this time will be charged at normal rates.
6. We cannot guarantee the sale of livestock due to market fluctuations. In the event of livestock failing to be sold, livestock will be returned to the property address stated on the Vendor Declaration and additional transport fees will be incurred.
7. It is your responsibility to ensure your livestock do not contain lice. If your sheep are found with lice at the market, all fines given by PRISA, will be taken from your sheep sale funds. If sheep are not sold or the fines for lice exceed any sale funds you receive, Jono's Sheep Services will charge a bill of the remaining amount via email to the client via both email.
8. Any animals that are not fit for transportation will not be taken to sale yards. Clients must ensure that livestock are fit for transport and comply with all relevant regulations. Staff will take all reasonable measures to ensure the safety and well-being of livestock during transport.
9. Staff will issue the client via email, a receipt of sale, when funds have been sent via the third party, to then be forwarded to the client's banking account as filled out on the Electronic Funds Transfer Form.
10. If the funds from the sale of your livestock do not cover the invoice of services provided by Jono's Sheep Services an invoice will be issued to the nominated email address, and must be paid with the 14-day grace period, in conjunction with our general Terms and Conditions, (found on our website, see section 10).
11. Basic services provided by staff, for the sale of livestock, include the following; transportation of animals, a 12.5% commission on remaining sale funds, and Nutrien's saleyard fees (this fee varies each market, we have no influence on this fee as it is beyond our control).
 - 11.1 Additional fees that may be incurred include the following items; truck transport and loading fees if your animals cannot be taken by a trailer (these fees vary with each sale, as it is

decided by trucking company and beyond our control), labour fees for yarding and loading your animals, work dog fees for the use of dogs, drone fees if used to locate/yard animals.

12. We are not liable for any loss or damage to livestock during transport or sale, except in cases of gross negligence or wilful misconduct.

12.1 Clients agree to indemnify and hold Jono's Sheep Services harmless from any claims, losses, or damages arising from the services provided.

13. Jono's Sheep Services & Jono's Cattle Services reserve the right to amend these Terms and Conditions at any time.

13.1 Clients will be notified of any changes in a timely manner.

14. By engaging Jono's Sheep Services & Jono's Cattle Services, clients acknowledge and agree these terms and conditions.
