**By signing below, I accept and understand that:**

1. Any changes to the above particulars must be notified to Jono's Sheep Shearing Services in writing. Jono's Sheep Shearing Services is under no obligation to verify the above details or change any details without written confirmation.
2. Payment will be deemed to have been made when Jono's Sheep Shearing Services has instructed its bank to credit the above account. Jono's Sheep Shearing Services will not be responsible for any delays in payments or error due to factors outside of the reasonable control of Jono's Sheep Shearing Services, including but not limited to delays or errors in the banking system, or errors in the above banking details provided by you, the customer.

3. Jono's Sheep Shearing Services cannot guarantee the sale of sheep due to market fluctuations. In the event of livestock failing to be sold, livestock will be returned to the property address stated on the Vendor Declaration and additional transport fees will be incurred.
4. Jono's Sheep Shearing Services will issue the client via email, a receipt of sale, when funds have been sent via the third party, to then be sent to the above client's banking account.
5. Please note: any animals that are transported without an NVD tag will carry additional charges as animals without NVD tags cannot be legally sold.
6. It is your responsibility to ensure your sheep do not contain lice. If your sheep are found with lice at the market, all fines given by the salespeople, will be taken from your sheep sale funds. If sheep are not sold or the fines exceed any sale funds you receive, Jono's Sheep Shearing Services will charge a bill of the remaining amount via email to the client via both email and post.
7. Jono's Sheep Shearing Services can give an estimated value of sheep prior to being consigned; however, these are only *estimated values* and are not an accurate representation of the market sale price at the time of sale. These prices may also differ between each of your individual livestock.
8. Livestock must travel with correct and valid vendor declaration and health check forms.
9. Privacy note: we collect, use, disclose and handle personal information in accordance with the Privacy Act 1988 (cth).
