Dear Friends,

Our Board and staff can't thank you enough for your continued support of the Child Advocacy Center (CAC). Your generous contributions of time, energy, and financial contributions have been critical in helping us protect and serve vulnerable and endangered children. We thank you for your creative and unwavering support!

CAC programs have grown to reach more children and families in 2024, providing them with the support and resources they needed to heal and stay safe and healthy. Trauma responsive therapy for children affected by child abuse, as well as education and training for families and professionals to help them prevent child abuse in the future were paramount for the year. Resources for families to help them better understand the signs of child abuse and how to respond when they suspect abuse continued throughout the year.

In 2024, children's needs for services continued to increase. We served 2,356 children and 1,608 caregivers in 2024. 1,131 were new cases, 69 were child trafficking cases, 754 were physical abuse cases, 908 were sexual abuse cases, and 239 required specialized forensic interviews.

The CAC continued to make connections and form new relationships throughout the community. These partnerships will have long lasting effects on furthering the values of the CAC – Together, breaking the cycle of child abuse.

Your support and dedication to protecting children who have experienced the tragedy of child abuse continues to inspire us and improve the lives of children in our community. Thank you for the honor of serving them with you!





IMPROVEMENTS

BUILDING UPGRADES - The CAC received an electrical / maintenance grant from Clay Electric allowing the center to perform building maintenance and upgrades to ensure a safe environment. THERAPY NOTES SYSTEM - CAC's Therapy Department received a grant from Capital City Bank to go paperless! Digitizing will allow the program to intake new clients more efficiently, in addition to saving on paper costs. This new system will increase client engagement, by giving clients access to a client portal which provides continuity of care and increased contact with their therapists.

CAC COMMUNITY TRAINING

The CAC received grant funding from Children's Trust of Alachua County (CTAC) focused on providing training for CTAC providers and community members on a variety of topics including Child Abuse Reporting, Human Trafficking, Understanding Complex Trauma, Normative Sexual Development in Children, and Internet Safety.
