

Many RI Seniors Face Economic Insecurity Need help paying for care

- 50% of RI 65+ Households income LESS THAN \$50,000/yr.
 - > 25% RI 65+ Households live on LESS THAN \$25,0

Actions & Advocacy

- Increase Subsidized Home/Community Services
- Expand Medicare Savings Program
- Look at Medicaid eligibility for older adults

Will careworkers be available???

Will my loved ones who help me get support???

Issues

- Healthcare Worker Crisis
- Wait list for Home Care
- Direct care staff wages
- Low Provider Reimbursements
- Lack of support/information for caregivers

Action & Advocacy

- Advocacy for Provider Reimbursement
- Advocacy for Direct Care staff wage increases
 - Strengthened Information & Navigation Services
 - Funding for Respite
- Paid leave for Caregivers
