stereotype---many old people are stupid and out of touch with modern technology, before listening to the sponsor's sales pitch. This ad confirmed a point made by Janice Blanchard and others that ageism is the last widely acceptable form of discrimination in our society. Would any company dare to run such an ad featured all people of color or one ethnicity instead of older women?

So what are we to do about ending ageism? First we need to become aware of the widespread messages and policies based on ageism, and analyze whether we have internalized some of those ageist notions. There's even some research indicating that if we as seniors buy into that prejudice, it can become a self-fulfilling prophecy that's bad for our own future health.

Ashton Applewhite has pointed out that "ageism is a prejudice that pits us against our future selves." (I recommend her TED talk "Let's End Ageism" on YouTube.) I was recently racing out of a grocery store, when at the exit I found myself stuck behind

down. Prejudices are socially-constructed ideas and values that are widespread, but we can recognize them and address them in ourselves.
