# OMB Clearance of the CSBG Annual Report

The CSBG Annual Report was cleared by the Office of Management and Budget in January 2017 with a 3-year approval. That means that the report clearance expires on January 31, 2020 -- which is *before* the FY 2019 data is collected by OCS (States must submit by March 31, 2020). Therefore, an updated clearance is needed before January 2020 to ensure the network can seamlessly submit their FY 2019 CSBG Annual Report.

While Module 1 data has been submitted by the State Offices using the OLDC portal to OCS since the original clearance date, local agency data in Modules 2, 3 and 4 was submitted directly to OCS for the first time this past April. The phased in approach of only submitting Module 1 initially gave the network two years to build systems, offer training on the new data elements, and build capacity to submit Module 2-4 data for FY 2018.

During the preparation for submitting this data we know that local agencies, State Community Action Associations, and State Offices identified some issues and areas where clarification and/or modification would be useful. Many of these observations about changes the network would like to see to the Annual Report have been submitted to OCS, NASCSP, and the Partnership on an ongoing basis. 6

To meet the need for a January 2020 clearance, however, OCS is submitting an updated package to OMB this month (August), which is focused on technical updates only. While there will be the formal 60-day and 30-day comment periods open for anyone in the network to submit comments on the clearance package, OCS will focus on technical items such as correcting typos, adding clarifications, and aligning Module 1 with the most recent State Plan format. A notice will be sent to the network when the package has been posted in the Federal Register. This is being called "Phase I" and will allow for continued collection and reporting of the same data points that are in the currently cleared Annual Report for the near future (FY 2019). This means the network does not need to rush to change state and local agency systems and processes in the short time frame leading up to March 31, 2020.

The more substantive changes to Modules 2, 3 and 4 that the network feels are needed will be addressed in the next OMB Clearance process (to be identified as "Phase II") which is projected to begin early 2020. That is when extensive input on any proposed content is expected and welcomed. All the national partners will be available to secure feedback to provide OCS with input inform any changes or modifications to the Annual Report. Discussion about the challenges, and the solutions to those challenges, will be shared through various communication channels. Be on the look-out for more information about how to submit your feedback and the feedback you hear from your peers to inform Phase II of the clearance.

## Lessons Learned about Data Analysis and Use

There is a new interest in being deliberate about collecting, aggregating, analyzing and using the data that we are collecting. The recognition that we have an overload of information to put to use has raised the understanding that we have to be more careful about the <u>quality</u> of the data, the <u>selection</u> of data that we think is <u>meaningful</u>, and the <u>skills of staff</u> who are being asked to become more data centric.



A number of webinars and power point resources are being developed to further assist in developing skills so that the data we have is USEFUL. We believe there are some basic techniques that anyone can do to begin to analyze program and agency data to be used for decision making.

Some of these techniques:

- Aggregate
- Count
- Compare
- Look at the Trends

A key element in the movement toward more data centric agencies

– more agencies engaged in active performance management -- is the

willingness to put data analysis to use for program improvement.

# CONDUCTING A ROMA AUDIT

More Information

Using ROMA principles, we know that we have to assess before we start to identify what we will do.

This assessment will allow us to establish a baseline of ROMA implementation.

If we don't have a baseline, we will not be able to say what has changed. If we can't say what has changed we will not be able to celebrate success.

WHERE ARE YOU WITH YOUR ROMA AUDIT?
Let us know how you have established a baseline.

Once the Assessment of your current ROMA status is done, you can establish

some steps to take toward the goal of increasing the ROMA Culture at your agency.

Here are some ways you can identify an agency that has a "ROMA Culture:"

- The agency recognizes and identifies with a Results Orientation.
- There is broad exposure of all staff, board, volunteers, etc. to ROMA basics (Intro to ROMA)
- 3. The Executive Staff and Board demonstrates/uses ROMA and Performance Management activities.
- 4. There are trained staff in trusted position
- The agency employs a shared language regarding performance.
- 6. The whole agency is involved (not just CSBG)
- ROMA is deliberately incorporated into existing regular activities

Who is the ROMA Champion at your agency?

- The person at the top of the agency (ED/CEO)?
- Someone from agency leadership (upper management) who has authority?
- ✓ Anyone else who feels passionate about the anti-poverty work the agency is doing!!!!!
  This can be the NCRP.

Don't be caught in the "I can't do anything because my ED doesn't buy-in to ROMA" trap! Take some action from where you are.

Talk to your peers and share ROMA ideas with them.

Catch them doing ROMA.

And then you will have a team to change the culture!!

As the holder of a national certification, you are responsible for maintaining your skills and knowledge in accordance with the recertification expectations identified by the Association of Nationally Certified ROMA Trainers and Implementers.

The current recertification process for NCRTs will remain in effect through December 2020. It includes a way to assure everyone who was originally certified as a Trainer prior to January 2018 has an understanding of the changes to the basic Introduction to ROMA curriculum as of that date and is familiar with the ROMA Next Generation material (supplemental to the basic "Intro" foundation).

If you were originally certified as NCRT in 2016, you are due for recertification this year!!!! Check the MY INFO tab <a href="http://www.roma-nptp.org/myinfo.html">http://www.roma-nptp.org/myinfo.html</a> if you want to see what the national data base has as your original certification date.

NOTE: NCRIs (Implementers) will begin to be eligible for recertification starting in January of 2020. (Anyone certified in the 2016 pilot year has been given an additional year in the first recertification period for NCRIs) Information about the NCRI recertification process will be posted by the Fall ICEP (late October).
