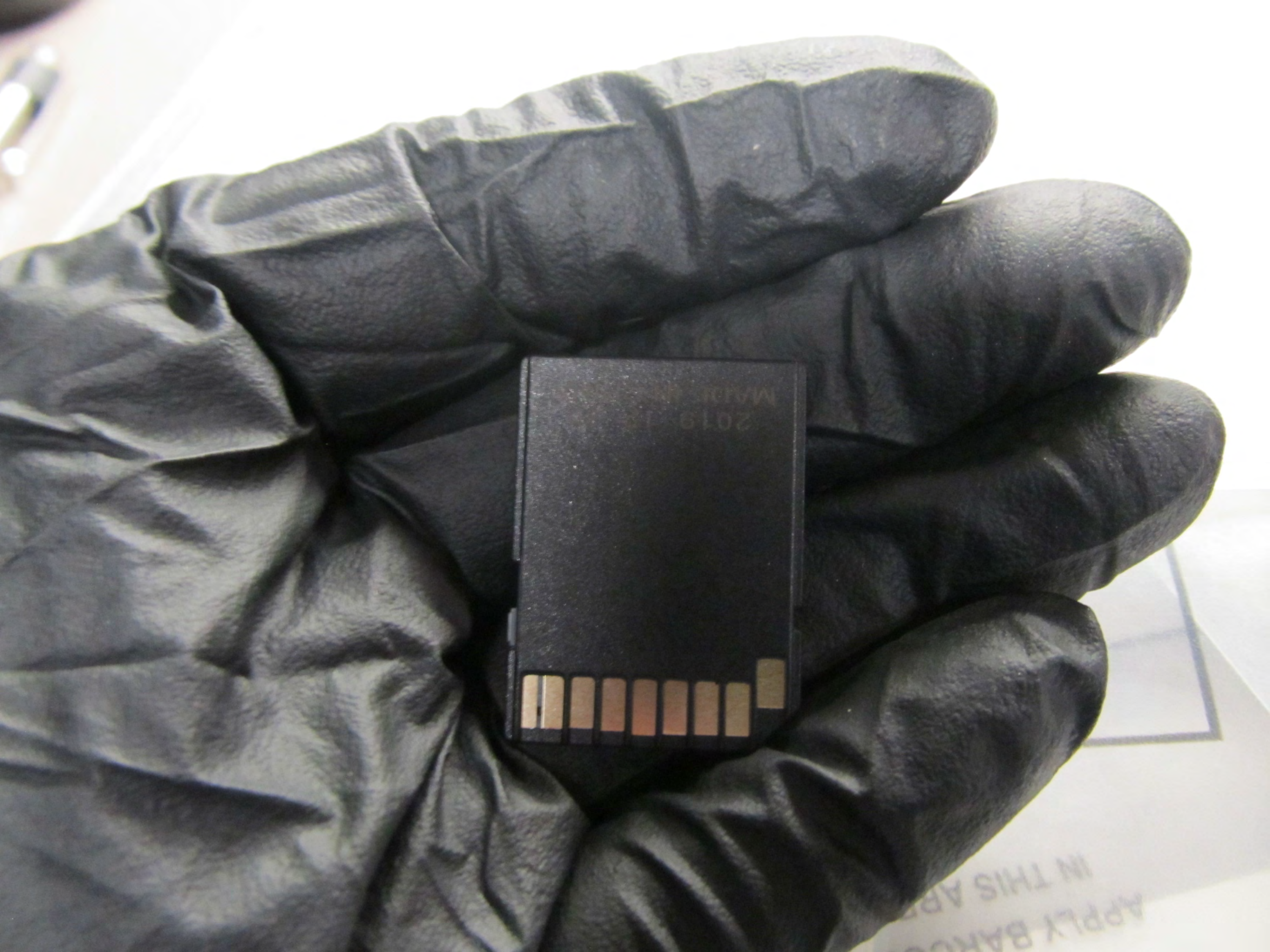

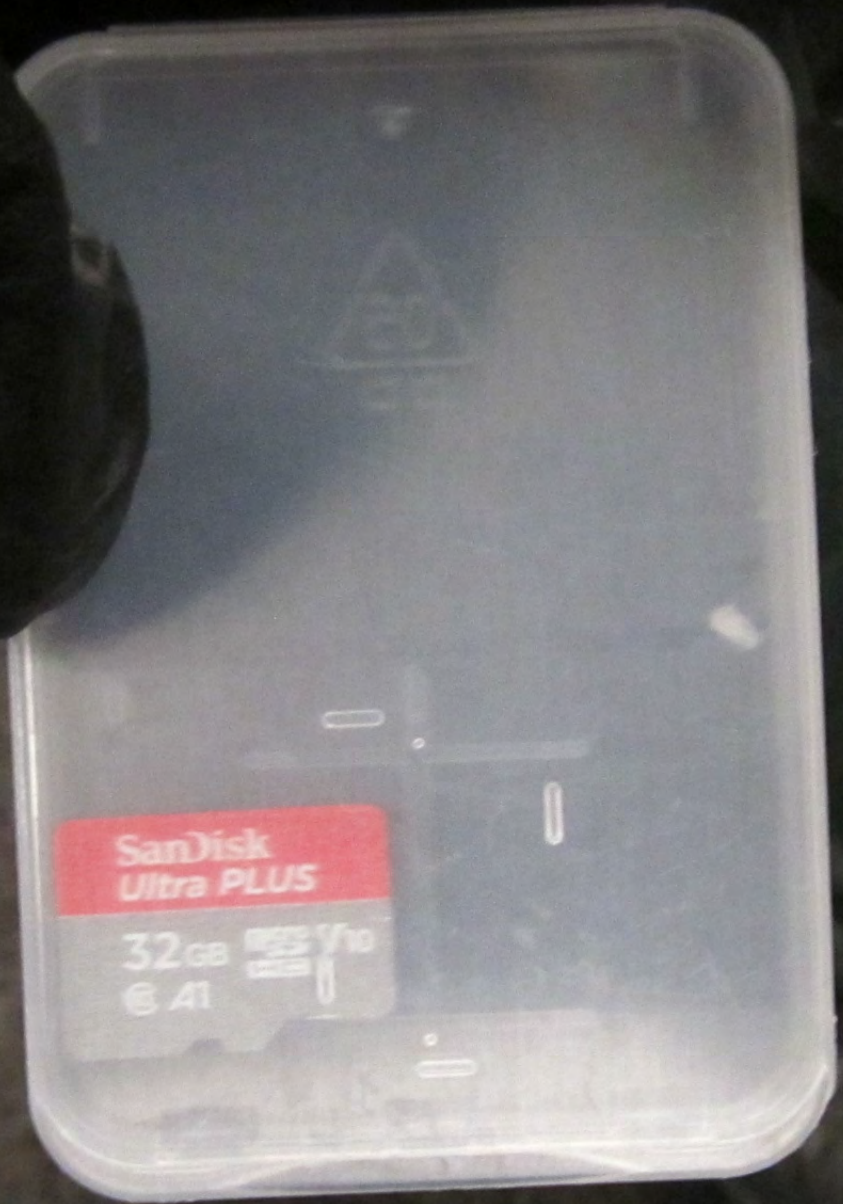

Law Enforcement will Intentionally Misinterpret Your Wording!

If You are Being Held By Police, Clearly State the Following:

"Am I Free to Leave?"

"I Am Invoking My Right to Remain Silent"

"I Am Invoking My Right to an Attorney"
