- 2. Report and Approval of Election Results (Secretary): It was moved & seconded to approve all election results as submitted; motioned carried.

 - A. It was moved and seconded to appoint Neal Fausset as the Director of Liaison and Special Projects; motion carried
- 5. Remarks and Presentations by Guests No guest present
 - A. Remarks and Presentations by CHSAA Representatives Justin Saylor was present for the meeting and provided comments during the conversations. - 6. Review and Approval of Minutes of Prior Meeting It was moved and seconded to pass the previous meeting minutes; motion carried.
- 7. Reports and Action Items by Board Members:
 - A. President Ken Hehir: No comment or report at this meeting
 - B. Vice President for Evaluation & Discipline John Bissell
 - i. HSSO Camp is on for this weekend with 13 officials registered currently.
 - 1. Will get meeting room to go over referee responsibilities in the diagonal system of control and

would like to use communication systems (coms) during every game.

- ii. Referee Rating System the coaches would like to add a rating system that has separate ratings specific to both Center and Assistant Referees positions.
 - ASO using the rating system, Dale does not appear to be using the rating system. If we create the
 system and rate the referees and games, then there should be some method to ensuring assignors
 "play by the rules". This new rating system could be similar to the rating system used for
 basketball (each sport uses 3 officials). There should be some safeguards in place to ensure
 appropriate assignment.
- C. Vice President for Liaison & Recruitment Conor McGahey
 - i. Badges are in, have been given to Mike and the invoice was submitted to Jason.
- D. Secretary Sonja Urano
 - i. An official expressed concern about a response received regarding the current rating system. This will be addressed when the new rating system (center and AR) is created.
 - ii. Mention was made that the current election results required each ballot be reviewed by hand.
- E. Treasurer Jason Hampton
 - i. Received a file folder from Bob and will obtain access to our bank account @ Chase Bank.
 - ii. Also received a thumb drive with monetary overview from the last year, a purposed budget for this year and a banking statement.
 - iii. Needs godaddy login to be able to maintain the website.
 - iv. Spoke to Monica to obtain access to the Arbiter payment, and Monica expressed interest in depositing the checks received @ the CHSAA office directly. Expressed interest in creating an account to be able receive credit card payments (through paypal).
 - v. It was moved & seconded to approve the purposed budget; motion carried.
- F. Director of Officials Clinics & Rules Interpreter Mike Chipman:
 - i. Membership is up to about 250 officials

 - i. Concerned that assignments being given to 500 level referees for a 100 level game.
 - 1. If we rate the games, then how to we get Dale to comply? Dale may be retiring or leaving Jeffco as an assigner. (Special Project)

- ii. How do we convey to the lower rated referees that they are unable to perform in a 100 level game?
 - 1. Referee needs to be addressing the issue with the assigner or clearly be told by the Board.
- iii. Assessments Would the schools/coaches be willing to reimburse for assessments?
 - Possibility of changing the officials pay scale to reflect a greater percentage of the additional pay to the top level officials.
