    - i. Phone call with CSA staff review of CHSAA dates alongside youth soccer plans, discussed recruitment of youth players to become Referees for opposite playing seasons, CHSAA will remind schools to avoid Saturday games a much as possible, keep communication lines open between HSSO and CSA.
