 - ii. Email from Jack Van Natta discussing game officials and lack of security presence at games / sites. This is in contrast to Football or Basketball games always having security present with is a CHSAA requirement. Create a recommendation to membership to file supplemental reports on inappropriate behavior (Team, Coaches, Parents, Sidelines, etc) any time there is an issue so CHSAA is aware. Also, file reports to report instances of good behavior for CHSAA to recognize those schools.

A. By-Law Vote - Special Ballot

Due to the COVID-19 pandemic and loss of a full year of high school soccer, the HSSO Board are recommending that we extend the term length of all elected officials (Board and Area Directors) by 12 months.

This will allow us to see through Season D and fully prepare for the 2021/22 year. We will return to a normal election cycle in 2022.

As this is a temporary bylaw change a majority vote is required by the membership.
