 -North Korea has halted nuclear and missile tests.
 -Negotiated the return of the remains of missing-in-action soldiers from the Korean War.
 -Imposed strong sanctions on Venezuelan dictator Nicholas Maduro and his inner circle.
 -Executive order preventing those in the U.S. from carrying out certain transactions with the Venezuelan regime, including prohibiting the purchase of the regime's debt.
 -Responded to the use of chemical weapons by the Syrian regime.
 -Rolled out sanctions targeting individuals and entities tied to Syria's chemical weapons program.
 -Directed strikes in April 2017 against a Syrian airfield used in a chemical weapons attack on innocent civilians.
 -Joined allies in launching airstrikes in April 2018 against targets associated with Syria's chemical weapons use.
 -New Cuba policy that enhanced compliance with U.S. law and held the Cuban regime accountable for political oppression and human rights abuses.
 -Treasury and State are working to channel economic activity away from the Cuban regime, particularly the military.
 -Changed the rules of engagement, empowering commanders to take the fight to ISIS.
 -ISIS has lost virtually all of its territory, more than half of which has been lost under Trump.
 -ISIS' self-proclaimed capital city, Raqqa, was liberated in October 2017.
 -All Iraqi territory had been liberated from ISIS.
 -More than a dozen American hostages have been freed from captivity all of the world.
 -Action to combat Russia's malign activities, including their efforts to undermine the sanctity of United States elections.
 -Expelled dozens of Russian intelligence officers from the United States and ordered the closure of the Russian consulate in Seattle, WA.
 -Banned the use of Kaspersky Labs software on government computers, due to the company's ties to Russian intelligence.
 -Imposed sanctions against five Russian entities and three individuals for enabling Russia's military and intelligence units to increase Russia's offensive cyber capabilities.
 -Sanctions against seven Russian oligarchs, and 12 companies they own or control, who profit from Russia's destabilizing activities.
 -Sanctioned 100 targets in response to Russia's occupation of Crimea and aggression in Eastern Ukraine.
 -Enhanced support for Ukraine's Armed Forces to help Ukraine better defend itself.
 -Helped win U.S. bid for the 2028 Summer Olympics in Los Angeles.
 -Helped win U.S.-Mexico-Canada's united bid for 2026 World Cup.
Defense
 -Executive order keeping the detention facilities at U.S. Naval Station Guantanamo Bay open.
 -\$700 billion in military funding for FY 2018 and \$716 billion for FY 2019.
 -Largest military pay raise in nearly a decade.
 -Ordered a Nuclear Posture Review to ensure America's nuclear forces are up to date and serve as a credible deterrent.
 -Released America's first fully articulated cyber strategy in 15 years.
 -New strategy on national biodefense, which better prepares the nation to defend against biological threats.
 -Administration has announced that it will use whatever means necessary to protect American citizens and servicemen from unjust prosecution by the International Criminal Court.
 -Released an America first National Security Strategy.
 -Put in motion the launch of a Space Force as a new branch of the military and relaunched the National Space Council.
 -Encouraged North Atlantic Treaty Organization (NATO) allies to increase defense spending to their agree-upon levels.
 -In 2017 alone, there was an increase of more than 4.8 percent in defense spending amongst NATO allies.
 -Every member state has increased defense spending.
 -Eight NATO allies will reach the 2 percent benchmark by the end of 2018 and 15 allies are on trade to do so by 2024.
 -NATO allies spent over \$42 billion dollars more on defense since 2016.
 -Executive order to help military spouses find employment as their families deploy domestically and abroad.
Veterans affairs
 -Signed the VA Accountability Act and expanded VA telehealth services,

es, walk-in-clinics, and same-day urgent primary and mental health care.
 -Delivered more appeals decisions – 81,000 – to veterans in a single year than ever before.
 -Strengthened protections for individuals who come forward and identify programs occurring within the VA.
 -Signed legislation that provided \$86.5 billion in funding for the Department of Veterans Affairs (VA), the largest dollar amount in history for the VA.
 -VA MISSION Act, enacting sweeping reform to the VA system that:
 -Consolidated and strengthened VA community care programs.
 -Funding for the Veterans Choice program.
 -Expanded eligibility for the Family Caregivers Program.
 -Gave veterans more access to walk-in care.
 -Strengthened the VA's ability to recruit and retain quality healthcare professionals.
 - Enabled the VA to modernize its assets and infrastructure.
 -Signed the VA Choice and Quality Employment Act in 2017, which authorized \$2.1 billion in addition funds for the Veterans Choice Program.
 -Worked to shift veterans' electronic medical records to the same system used by the Department of Defense, a decades old priority.
 -Issued an executive order requiring the Secretaries of Defense, Homeland Security, and Veterans Affairs to submit a joint plan to provide veterans access to access to mental health treatment as they transition to civilian life.
 -Increased transparency and accountability at the VA by launching an online "Access and Quality Tool," providing veterans with access to wait time and quality of care data.
 -Signed legislation to modernize the claims and appeal process at the VA.
 -Harry W. Colmery Veterans Educational Assistance Act, providing enhanced educational benefits to veterans, service members, and their family members.
 -Lifted a 15-year limit on veterans' access to their educational benefits.
 -Created a White House VA Hotline to help veterans and principally staffed it with veterans and direct family members of veterans.
 -VA employees are being held accountable for poor performance, with more than 4,000 VA employees removed, demoted, and suspended so far.
 -Signed the Veterans Treatment Court Improvement Act, increasing the number of VA employees that can assist justice-involved veterans.
The Economy –
The DOW
 The US stock market is a barometer of economic activity and since President Trump was elected President it has skyrocketed.
 The stock market on January 17th, 2018, said it all. On that day the Dow broke 26,000 points for the first time in its history. As a result the Dow broke the record for the fastest 500, 1,000, 2,000, 3,000, 4,000, 5,000, 6,000 and 7,000 point increases between major milestones in the history of the Dow. All of these increases occurred since Donald Trump was elected President.
 After President Trump was elected the DOW exploded. On November 8th, 2016, the DOW stood at 18,332. Since that date the DOW has soared and it never looked back.
 Not only has the DOW skyrocketed since Donald Trump was elected President, the market's rise is record breaking. Since the 2016 election, the DOW has closed at new record all-time highs 103 times! (President Obama never saw a new all-time high in the DOW his entire first term and only saw 105 all-time closing highs from his first election win until Trump's.)
 President Trump's first year in office (2017) saw the most all-time stock market closing highs (71) as well as the largest increase in DOW history (4,956 points). Prior to 2017, no year in the DOW's more than 100-year history ever saw the DOW increase by more than 3,500 points, let alone 4,900. The most all-time highs in a year prior to 2017 was 69 in 1995. Since President Trump was elected President the DOW tied the record for the most consecutive all-time closing highs in a row. In January of 1987 President Reagan saw the DOW increase to new all-time highs a record 12 days in a row. In February of 2017, President Trump matched Reagan's record.
 The DOW today stands at nearly 40% up from where it was in November of 2016, the day of the election!
GDP and Debt
 Rex Sinquefeld at Forbes in October of 2016, shortly before the 2016 election, wrote the following –
 The Obama recovery of the last

seven years remains the worst in postwar American history. Average gross domestic product (GDP) growth since the bottom of the recession in 2009 was barely above 2.1% per year. The average since 1949 is well above 4% per year during the previous 10 expansions.
 This result is not just bad, it is catastrophic. The average American should not be wondering if his or her income is a bit above or below 2007 levels. Just by historical averages, the average American should be 20% better off than in 2007. And this slow growth is settling in as a permanent new-normal.
 I believe the root cause of abysmal growth is the huge tax increases imposed by Obama and the Democrats in Congress since 2008. The most harmful were the
 increase in the capital gains tax from 15 to 20 percent, the increase in top bracket income from 35 to 39.6 percent, and the new tax of 3.8 percent on investment income in the Affordable Care Act (ACA). The massive increase in regulatory burden through the ACA and Dodd-Frank bills are also crushing, but unfortunately are harder to measure. President Trump however reached a GDP of 4.2% in the 2nd quarter of 2018 and 3.5% in the 3rd quarter. With a GDP in the 4th quarter of around 3%, the GDP for the year will be greater than 3%. Something the prior President Obama never did and said no longer could be done.
 In regards to debt, President Obama increased the amount of US debt astronomically. By the time Obama left office he had doubled the US debt to \$20 trillion and incurred as much debt as all previous Presidents combined. President Trump is slowing that trend.
 President Trump has added about \$1.7 to the national debt and spending must come down. But because of the increase in GDP, the Debt to GDP ratio under President Trump is declining. President Obama increased the US debt to GDP ratio by 40% from around 60% in 2009 to over 100% in 2016.
 With his increasing GDP and slowing of debt increases, President Trump has managed to decrease the debt to GDP ratio in the 2 years since the 2016 election. This is a very good result that is rarely mentioned by the MSM.
Jobs, Employment and Wages
 President Trump is the 'Jobs President'. Yesterday, the Bureau of Labor Statistics reported that 250,000 new jobs were created in October. In President Trump's first two years since elected President, the US has gained over 4.3 million jobs. (In President Obama's first two years the US lost over (4.2) million jobs.) More people are working in the US than ever before and unemployment is at 50 year lows landing at 3.7% last month.
 The President's tax plan passed in late December 2017 is greatly benefiting Americans and American companies. Employees will see increases in their income tax refunds next year due to the lower Federal taxes.

Millions of Americans received bonuses due to the tax cuts and major companies announced plans to move capital and operations to the US due to these cuts. On top of income tax refund increases, Americans also are benefiting from the highest wage increases in a decade.
Foreign Policy
 President Trump vowed to destroy ISIS. Despite President Obama saying that ISIS will be around for a generation, these murderers and terrorists in the Middle East were decimated over the President's first year in office. Both Syria and Iraq declared victory over ISIS and due to President Trump's resolve, less than 1,000 ISIS fighters remain.
 President Trump met with the Pope, leaders of 50 Muslim countries and

federal employees.* Exiting the US from the TPP.
 Now the question lingers will he get the fence across the Mexican border?

 Here's the law.
 8 U.S. Code § 1324 – Bringing in and harboring certain aliens
 (a) Criminal penalties
 (1) (A) Any person who—
 (i) knowing that a person is an alien, brings to or attempts to bring to the United States in any manner whatsoever such person at a place other than a designated port of entry or place other than as designated by the Commissioner, regardless of whether such alien has received prior official authorization to come to, enter, or reside in the United States and regardless of any future official action which may be taken with respect to such alien;
 (ii) knowing or in reckless disregard of the fact that an alien has come to, entered, or remains in the United States in violation of law, transports, or moves or attempts to transport or move such alien within the United States by means of transportation or otherwise, in furtherance of such violation of law;
 (iii) knowing or in reckless disregard of the fact that an alien has come to, entered, or remains in the United States in violation of law, conceals, harbors, or shields from detection, or attempts to conceal, harbor, or shield from detection, such alien in any place, including any building or any means of transportation;
 (iv) encourages or induces an alien to come to, enter, or reside in the United States, knowing or in reckless disregard of the fact that such coming to, entry, or residence is or will be in violation of law; or
 (v) (I) engages in any conspiracy to commit any of the preceding acts, or (II) aids or abets the commission of any of the preceding acts, shall be punished as provided in subparagraph (B).
 (B) A person who violates subparagraph (A) shall, for each alien in respect to whom such a violation occurs— (i) in the case of a violation of subparagraph (A)(i) or (v)(I) or in the case of a violation of subparagraph (A)(ii), (iii), or (iv) in which the offense was done for the purpose of commercial advantage or private financial gain, be fined under title 18, imprisoned not more than 10 years, or both;
 (ii) in the case of a violation of subparagraph (A)(ii), (iii), (iv), or (v)(II), be fined under title 18, imprisoned not more than 5 years, or both;
 (iii) in the case of a violation of subparagraph (A)(i), (ii), (iii), (iv), or (v) during and in relation to which the person causes serious bodily injury (as defined in section 1365 of title 18) to, or places in jeopardy the life of, any person, be fined under title 18, imprisoned not more than 20 years, or both; and
 (iv) in the case of a violation of subparagraph (A)(i), (ii), (iii), (iv), or (v) resulting in the death of any person, be punished by death or imprisoned for any term of years or for life, fined under title 18, or both.
 Instead of Americans having continuous conversations of the innocent people in this country who are being murdered by illegal immigrants because of the responsible parties, namely corrupt politicians, how about having conversations of how the people in this country are magnifying the laws against corruption within their ranks so that we don't have to worry about illegal immigrants and their crimes any longer (Deuteronomy 25:1; 1 Peter 4:17)?
