



### Male Arrested After Stabbing in Oshawa

A male is facing charges after stabbing another male at a residence in Oshawa.

On Wednesday, February 4, 2026, members of Central East Division responded to an armed person call in the area of Athol Street East and Ritson Road South. A male stabbed another male after a verbal altercation inside a residence. Officers arrived on scene and took the suspect into custody without incident. The victim suffered serious injuries and was treated by emergency medical personnel.

**Robert RYALEN**, age 60 from Oshawa is charged with: Assault Cause Bodily Harm, Assault with a Weapon, and Possess Weapon Dangerous.

### Male Arrested After Making Threats in Whitby

A male is facing charges after making threats toward co-workers at a business in Whitby.

On Monday, February 2, 2026, members of Central West Division were contacted after an employee made threatening comments toward other employees at the Durham Region Waste Management Facility located at 1640 Ritson Road North. Investigators located the suspect at his residence and took him into custody without incident. The suspect's legally owned firearms were voluntarily surrendered to DRPS.

**Damien JOHNSTON**, age 34 from Oshawa is charged with: Uttering Threats.

### Male Arrested After Online Threats Made Toward Mosque in Pickering

A male is facing charges after making online threats toward a mosque in Pickering.

On Wednesday, January 28, 2026, members of the Hate Crime and Extremism Unit received information from the Royal Canadian Mounted Police (RCMP) about threats made to the Ahmadiyya Durham Mosque Baitul Mahdi located at 3505 Salem Road in Pickering.

The suspect was identified and arrested on Thursday, January 29, 2026 at a residence in Toronto without incident.

**Ivan John MUJAN**, age 65 from Toronto is charged with: Uttering Threats.

### Female Arrested for Impaired After Collision in Whitby

A female is facing several charges after causing a collision while impaired near a school in Whitby.

On Friday, January 30, 2026, at approximately 3:50 p.m., members of Central West Division responded to a collision in the area of Fifewood Crescent and Fallingbrook Street. A grey Kia sedan collided with a parked white Hyundai sedan. Both vehicles were in the area to pick up children from a nearby public school. The driver of the Hyundai attempted to speak with the driver of the Kia, however the Kia fled the area.

Several witnesses reported that the driver of the Kia appeared impaired. A short time later officers located the Kia at a nearby residence. The driver showed signs of impairment and was taken into custody without incident.

No persons involved in the collision suffered any physical injuries.

After completing two separate breath tests, the accused registered a blood alcohol level of 170 mg and 180 mg of alcohol in 100 ml of blood. The legal limit for alcohol consumption is 80 mg of alcohol in 100 ml of blood.

A 32-year-old female from Whitby is charged with: Operation While Impaired, Operation While Impaired – Exceed, Fail to Remain at Accident, and Dangerous Operation.

### Three Suspects Wanted After Arson in Oshawa

Police are searching for at least three suspects after they started a fire in a residence in Oshawa.

On Tuesday, February 3, 2026, at approximately 11:30 p.m., members of Central East Division responded to a house fire in the area of Richmond Street East and Ritson Road North. Three males entered a residence and started a fire before fleeing the area. Officers arrived on scene and found the main floor of the residence engulfed in flames. A male was evacuated from the home and transported to a local-area hospital with serious, non-life-threatening injuries. Oshawa Fire attended the scene and extinguished the fire.

Three male suspects fled the area prior to police arrival in a black sedan.

### Male Arrested After Assault and Fleeing from Police in Oshawa

On Tuesday, January 27, 2026, at approximately 12:10 p.m., members of Central East Division responded to a disturbance call in the area of Wentworth Street West and Oxford Street. The suspect reportedly assaulted and



forced the victim into a vehicle before fleeing the area. Officers located the suspect vehicle and initiated a traffic stop, however the vehicle fled from police, striking another vehicle. After a brief pursuit, officers made intentional contact with the suspect vehicle, successfully bringing it to a stop. The suspect was taken into custody. The victim suffered minor injuries. The driver and passenger of the vehicle involved in the collision with the suspect vehicle suffered minor injuries.

The suspect was wanted on outstanding warrants at the time of his arrest.

### Male Arrested After Importing Prohibited Weapons Oshawa

On Wednesday, January 28, 2026, investigators from the Central East Division Criminal Investigations Branch completed an investigation into a male believed to have imported prohibited conducted energy weapons (tasers) into Canada. Investigators, with the assistance of the East Division Crime Team, and Central East Division Community Response Unit, executed a search warrant at a residence in the area of Ritson Road South and Olive Avenue. The suspect was located inside the residence and taken into custody without incident. Two tasers disguised as flashlights were located and seized.

**Derek Norman HENDERSON**, age 49 from Oshawa is charged with: Import Prohibited/Restricted Weapon, and Possess Prohibited/Restricted Weapon.

### Impaired Driver Facing Charges After Fleeing Police in Clarington

On Monday January 26, 2026, at approximately 3:30 p.m., members of East Division responded to an

impaired driver call in the area of Milligan Street and Port of Newcastle Drive. A vehicle was reportedly doing donuts and driving dangerously in the area. Officers located the vehicle and attempted to initiate a traffic stop, however the vehicle failed to stop. Police engaged in a brief pursuit before discontinuing due to the dangerous driving of the suspect. A short time later, officers located the suspect vehicle after it went off the roadway. The suspect surrendered to police and was taken into custody without incident.

### Fatal Collision in Pickering

On Wednesday, January 28, 2026, at approximately 7:10 a.m., members of West Division responded to a collision in the area of Kingston Road and Merritton Road. A Toyota sedan was travelling westbound on Kingston Road when it crossed into the oncoming lanes and collided head-on with a Subaru SUV travelling eastbound.

The 57-year-old male driver of the Toyota was transported to a Toronto-area trauma centre where he has since succumbed to his injuries.

The 67-year-old female passenger of the Subaru was transported to a Toronto-area trauma centre with life threatening injuries where she remains in critical condition. The 68 -year-old male driver of the Subaru was transported to a local-area hospital with minor injuries.

### Two Suspects Charged in Connection with Multiple Break-and-Enters

On Friday, January 23, 2026, at approximately 3:10 a.m., officers responded to a check-on-well-being call after a vehicle was located in a ditch. The K9 Unit arrived on scene and determined that the vehicle was stolen. With the assistance of officers from East

Division, K9 tracked two individuals to a commercial building in Clarington, where they were arrested. During the search of the vehicle, officers seized a large quantity of stolen cigarettes, lottery tickets, point-of-sale terminals and break-and-enter tools.

Through further investigation, it was determined that the suspects were connected to two commercial break-and-enters in the immediate area, prior to the collision.

### Two suspects were arrested after fleeing a single vehicle collision in Clarington

On Friday, January 23, 2026, at approximately 3:10 a.m., officers responded to a check-on-well-being call after a vehicle was located in a ditch. The K9 Unit arrived on scene and determined that the vehicle was stolen. With the assistance of officers from East Division, K9 tracked two individuals to a commercial building in Clarington, where they were arrested. During the search of the vehicle, officers seized a large quantity of stolen cigarettes, lottery tickets, point-of-sale terminals and break-and-enter tools.

Through further investigation, it was determined that the suspects were connected to two commercial break-and-enters in the immediate area, prior to the collision. Investigators have since charged the suspects in relation to five commercial break-and-enters across the Region.

Peace Officer, Theft of Motor Vehicle and Fail to Comply Probation X14.

**Michael WINN**, age 59 from Oshawa is charged with: Break and Enter Non-Dwelling Commit X4, Possess Property Obtained by Crime Over \$5000 X2, Possess Property Obtained by Crime Under \$5000, Disguise with Intent X4, Theft of Motor Vehicle and Fail to Comply Probation X6.

### Suspects Wanted After Jewelry Store Robbery in Oshawa

On Wednesday, January 21, 2026, at approximately 6:40 p.m., members of Central East Division responded to a robbery call at Oshawa Jewellery located in the Oshawa Centre at 419 King Street West. Three males entered the mall and attended the jewelry store where they smashed display cases before fleeing with jewelry. One of the suspects was intercepted in the mall and taken into custody. The other two suspects fled the mall into a waiting vehicle. The suspect vehicle fled the area prior to police arrival.

A 13-year-old male from Hamilton is charged with: Robbery, Disguise with Intent, and Possession of Property Obtained by Crime Over \$5000.

### Male Arrested Following Firearm Investigation in Bowmanville

A male is facing several firearm charges after an investigation by the Gun and Gang Unit in Bowmanville.

On Wednesday, January 21, 2026, members of the DRPS Gun and Gang Unit (GGU) completed a firearm investigation and executed a search warrant at a residence in the area of Green Road and Baseline Road.

A search of the residence located a handgun, three prohibited overcapacity magazines, ammunition, and drugs

**Nicholas Alexander RILEY**, age 28 from Bowmanville is charged with: Possess Loaded Restricted/Prohibited Firearm, Possess Prohibited/Restricted Device x3, Possession of Schedule I Substance for the Purpose of Trafficking (cocaine), Possession of Schedule I Substance for the Purpose of Trafficking (percocet), Possession Contrary to Order, Fail to Comply with Probation Order x2, and Fail to Comply with Release Order x3.

At the time of his arrest, the suspect was bound by probation and release orders.
