Male Facing Charges After Child Luring Investigation

A 19-year-old male has been arrested after a child luring investigation.

In December 2024, members of the DRPS Internet Child Exploitation Unit (ICE) began an investigation into an adult male communicating with a 13-year-old victim online. The male sent sexually explicit messages and shared sexually explicit material with the victim.

On November 26, 2025, members from the DRPS ICE Unit executed a Criminal Code Search Warrant at the suspect's residence in Bowmanville and arrested the suspect without incident.

Police are concerned there may be other victims and would like to speak with anyone with information. The accused operated under the username "stoymaso" on Discord.

Mason STOYKE, age 19 of Bowmanville, is charged with: Luring a Person Under the Age of 16 for the Purpose pf Facilitating the Offence of Sexual Assault; Luring a Person Under the Age of 16 for the Purpose of Facilitating the Offence of Sexual Interference; Making Sexually Explicit Material Available to a Person Under 18 for the Purpose of Making Child Sexual Abuse and Exploitation Material and Luring a Person Under the Age of 18 for the Purpose of Making Child Sexual Abuse and Exploitation Material

Police are looking to identify a suspect following a stabbing in Oshawa

On Monday, November 24, 2025, at approximately 9:00 p.m., members of Central East Division responded to the area of Parkwood Court and Simcoe Street North. Upon arrival, officers located a male suffering from stab wounds. The victim advised he had approached a group of people during which time an altercation ensued and the victim was stabbed. The victim was transported to a Toronto area hospital with non-life-threatening injuries. The incident initially took

place in the area of Centre Street South and Debwewin Miikan in Oshawa. The suspect is described as:

The suspect is described as: male, White approximately 25 years old, wearing a hat and black jacket.

Nine Arrested After Gun and Drug Investigation

Six males and three females

are facing numerous charges following a drug and gun investigation.

On Tuesday, November 18, 2025, members of the Gun & Gang and Drug Enforcement Units, with the assistance of Kawartha Lakes Police Service, concluded an investigation into nine suspects.

Multiple search warrants were executed at residences in Ajax, Oshawa, Toronto and Lindsay by the DRPS Tactical Support Unit, Toronto Police Emergency Task Force, and Peterborough Police Service's Tactical Support Unit. Officers seized more than 700 grams of cocaine, 300 grams of fentanyl, 100 grams of MDMA, 90 grams of crystal methamphetamine, as as approximately \$30,000 in Canadian currency. Five hand guns were also located and seized.

All suspects were taken into custody without incident.

Five Youth Arrested After Attempted Robbery in Ajax

Five male youth have been taken into custody after attempting to rob a cell phone store in Ajax.

On Monday, November 24, 2025, at approximately 1:20 p.m., members of West Division responded to a suspicious person call at the Freedom Mobile located at 235 Bayly Street West. Employees contacted police after seeing five males wearing masks and gloves sitting in a parked vehicle in front of the business.

The suspects attempted to enter the business but were unsuccessful after employees locked the doors. Officers located the suspect vehicle behind the business and were able to block it, however, all five suspects fled on foot. After a brief foot pursuit, all suspects were taken into custody. The suspect vehicle was determined to be stolen. A 16-year-old male from Mississauga is charged with: Robbery, Possession of Property Obtained by Crime Over \$5000, and Disguise

with Intent.

A 15-year-old male from Toronto is charged with: Robbery, Possession of Property Obtained by Crime Over \$5000, and Disguise with Intent. He is currently on conditions stemming from previous robbery and weapons charges.

A 17-year-old male from Toronto is charged with: Robbery, Possession of Property Obtained by Crime Over \$5000, and Disguise with Intent. He is currently on conditions stemming from previous break-and-enter charges.

A 17-year-old male from Brampton is charged with: Robbery, Possession of Property Obtained by Crime Over \$5000, and Disguise with Intent.

A 16-year-old male from North York is charged with: Robbery, Possession of Property Obtained by Crime Over \$5000, and Disguise with Intent.

Youth on Release Order Arrested for Oshawa Stabbing

Several weeks ago, a 16year-old male was arrested for a violent criminal offence involving a weapon. He was held for bail and later released on conditions, including house arrest. Within a week, he was arrested again for breaching those conditions and was subsequently released a second time under the same terms. On November 21, 2025, he was once again arrestedthis time in connection with a stabbing in Oshawa-while also facing new charges for breaching his court-imposed conditions. This series of repeated breaches and escalating violence highlights ongoing concerns about the effectiveness of current bail and release practices.

On Thursday, November 20, 2025, at approximately 12:30

p.m., members from East Division responded to a stabbing in the area of Coldstream Drive and Harmony Road North. Officers arrived on scene and located two students from Maxwell Heights Secondary School that had been stabbed. Both were taken to Toronto-area hospitals with non-life-threatening injuries.

On Friday, November 21, 2025, members of the East Division Criminal Investigations Branch, with the assistance of the East Division Community Response Unit and Tactical Support Unit, executed a search warrant at a residence in Oshawa. The suspect was located and taken into custody without incident.

Two Suspects Face More than 90 Charges After Break-and-Enter Investigation

More than 90 charges have been filed against two suspects following a break-andenter investigation that led to the recovery of a substantial amount of stolen property.

Beginning on Tuesday,

October 7, 2025, members of West Division responded to a series of commercial break-and-enters that we're linked to a small crime group. Investigators identified the suspects, who were responsible for committing several thefts, including vehicle and licence plate thefts, across the Greater Toronto Area.

On Friday, November 14, 2025, members of the West Division Crime Team observed the suspects operating a stolen vehicle. Both

suspects exited the vehicle and attempted to flee the area on foot but were taken into custody.

As a result of this investigation, numerous stolen items were located, including: two pick-up trucks, a RV trailer, a large amount of designer sunglasses, contracting tools, beauty supplies, a large amount of vapes, jewelry, cell phones, several stolen licence plates, and numerous stolen car keys.

Female Arrested After Fleeing a Patrol Vehicle in Oshawa

A female is facing several charges after fleeing from a patrol vehicle in Oshawa. On Friday, November 21, 2025, at approximately 12:40 a.m., a member of the DRPS RIDE team was on protective patrol when he initiated a traffic stop in the area of King

Street West and Thornton Road South. The suspect vehicle failed to stop when the officer activated their emergency equipment. The officer initiated a brief pursuit but discontinued when the vehicle began travelling at a high rate of speed.

A short time later, officers located the suspect vehicle abandoned off the roadway near Park Road and Hillside Avenue after it collided with a large boulder. Police searched the area and located the suspect driver fleeing on foot. The suspect was taken into custody and transported to a local-area hospital with minor injuries from the collision. The suspect was also wanted on several other charges.
