SERIOUS SINGLE MOTOR VEHICLE COLLISION IN UXBRIDGE

A male has been arrested after an armed robbery at a convenience store in Ajax.

On Wednesday, November 19, 2025, at approximately 8:50 p.m., members of West Division responded to a robbery at a convenience store in the area of Harwood Avenue South and Station Street. A suspect entered the store and held a knife toward the employee.

The suspect then stole a quantity of items and fled the

store.
Police located the suspect a short distance away and he was arrested without incident.

SERIOUS SINGLE MOTOR VEHICLE COLLISION IN UXBRIDGE

A 22-year-old male and his 20-year-old male passenger were seriously injured after a single motor vehicle collision in Uxbridge.

On Wednesday, November 19, 2025, at approximately 7:40 a.m., members of North Division responded to a single motor vehicle collision in the area of York Durham Line and Aurora Road in the Township of Uxbridge.

The vehicle was travelling eastbound on Aurora Road when it crossed the intersection at York Durham Line, continuing eastbound onto a private road. The vehicle entered the private road at a high rate of speed leaving the roadway into a large field.

The 22-year-old male driver and his 20-year-old male passenger were transported to a Toronto-area trauma centre. The 22-year-old male sustained serious but non-life-threatening injuries. The 20-year-old passenger remains in critical condition.

FATAL COLLISION IN BEAVERTON

Two passengers have succumbed to their injuries after a vehicle collision in Beaverton. On Wednesday, November 19, 2025, at approximately 8:00 p.m., member of North Division responded to a collision involving a tractor trailer and a small SUV on Regional Road 15 between Simcoe Street and Thorah Side Road. A commercial tractor trailer was reversing into a private driveway off of Regional Road 15, with its trailer across the width of the roadway, when it was struck by a Toyota SUV travelling eastbound on Regional Road 15.

There were three occupants in the Toyota. The driver, a 72-year-old male, was transported to a local-area hospital with serious injuries and subsequently transported to a Toronto-area trauma centre. An 88-year-old male passenger was transported a local-area hospital in critical condi-

tion but later succumbed to his injuries. A 71-year-old female passenger was pronounced deceased at the scene.

The 44-year-old male driver of the tractor trailer remained on scene and cooperated with police. He did not sustain any physical injuries.

MALE FACING CHARGES AFTER CHILD LURING

A 30-year-old male has been arrested after a child luring investigation.

In late May 2025, members of the DRPS Internet Child Exploitation Unit (ICE) began an investigation into an adult male communicating with a 12-year-old girl online. The male sent sexually explicit messages and shared sexually explicit material to the victim.

On November 11, 2025, members from the DRPS ICE Unit executed a Criminal Code Search Warrant at the suspect's residence in Bowmanville and arrested the suspect without incident.

Police are concerned there may be other victims and would like to speak with anyone with information. The male suspect operated under the username "sinister.illustrations."" on TikTok and Instagram

Under the Age of 18 for the Purpose of Facilitating Making Child Sexual Abuse and Exploitation Material.

TWO STUDENTS RECOVERING AFTER BEING STABBED IN OSHAWA

Two high-school students are recovering after being stabbed off school property during their lunch break in Oshawa.

On Thursday, November 20, 2025, at approximately 12:30 p.m., members from East Division responded to a stabbing in the area of Coldstream Drive and Harmony Road North. Officers arrived on scene and located two students from Maxwell Heights Secondary School that had been stabbed. Both were taken to Toronto-area hospitals with non-life-threatening injuries.

Both victims, ages 14 and 16 were off school property at the time of the incident. The school was put in a hold and secure for approximately 45 minutes while officers searched for the suspects.

Police are searching for two suspects. The first suspect is described as male, Black with a light complexion, 15-16 years old. He was wearing a black track suit.

The second suspect is described as male, Black with a dark complexion,15-16 years old. He was wearing a dark coloured track suit.

Police have arrested a suspect after a shooting in Oshawa left one victim with serious injuries.

On Sunday, November 9, 2025, at approximately 10:20 a.m., members of Central East Division responded to shooting at a residence in the area of Simcoe Street North and Bond Street West. Officers arrived on scene and located a female who had been shot. The victim was transported to a local area hospital with serious, non-lifethreatening injuries.

The suspect fled the area prior to police arrival.

On Thursday, November 13, 2025, the suspect was arrested without incident.

Deondre BLAKE, age 19 of Waterdown has been charged with several offences including: Aggravated Assault; Discharge Firearm with Intent to Wound, Endanger Life or Prevent Arrest; Assault with a Weapon or Imitation Weapon; Possess Restricted or Prohibited Firearm Knowingly Holding a Licence and Registration Certificate; Carry Concealed Weapon; Use of Firearm During Commission of an Offence and Point Firearm.

ONE MALE DECEASED IN DURHAM REGION'S EIGHTH HOMICIDE OF 2025

A 22-year-old male has been shot and killed in Durham Region's eighth homicide of 2025.

On Sunday, November 16, 2025, at approximately 11:10 p.m., members from North Division responded to an armed person call in the area of Mara Road and Simcoe Street in Beaverton for reports of gunshots. A short time later police received a phone call advising a male had been dropped off at a local

area hospital suffering from a gunshot wound. The male was later pronounced deceased.

At this time, investigators believe this was an isolated incident.

LOADED FIREARM AND DRUGS SEIZED IN

Officers seized a loaded firearm and drugs following the execution of a search warrant in Bowmanville.

BOWMANVILLE

On Thursday, November 6, 2025, members of the DRPS East Crime Team concluded an investigation which resulted in a Criminal Code search warrant and a Controlled Drugs and Substances search warrant being executed at a residence in the area of Bowmanville Avenue and Hartwell Avenue. Officers seized a loaded handgun, a large quantity of cocaine and fentanyl, as well as cash.

Four individuals were at the residence and arrested without incident.
