



Male Arrested After Theft from Oshawa Centre

A male is facing several charges after stealing items from an electronics kiosk and brandishing a knife at the Oshawa Centre. On Thursday, January 22, 2026, at approximately 8:10 a.m., members of Central East Division responded to a robbery call at the Oshawa Centre located at 419 King Street West. A male was seen stealing items from a cell phone kiosk. Oshawa Mall security confronted the suspect who brandished a knife and fled the area in a vehicle. Later that day, the suspect was located in Brampton where he was taken into custody by Peel Regional Police. Custody of the suspect was transferred to investigators from the DRPS Robbery Unit. The suspect presented a false name to police but investigators were able to correctly identify him.

Ekampreet SINGH, age 27 from Brampton is charged with: Assault with a Weapon, Mischief Under \$5000, Theft Under \$5000, Obstruct Peace Officer, Personation to Avoid Arrest, Drive Motor Vehicle While Suspended, Fail to Comply with Probation Order, Fail to Comply with Release Order, and Fail to Comply with Undertaking.

Pedestrian in Life-Threatening Condition After Collision in Ajax

A pedestrian remains in critical life-threatening condition following a collision in Ajax. On Thursday, January 22, 2026, at approximately 11:05 a.m., members of West Division responded to a collision involving a pedestrian at the intersection of Kingston Road West and Ritchie Avenue. A 57-year-old female pedestrian was struck by a pick-up truck while crossing the roadway on the west side of the intersection. The female was transported to a Toronto-area trauma centre where she remains in life-threatening condition. The driver remained on scene and cooperated with police.

Suspects Wanted After Jewelry Store Robbery in Oshawa

One youth is in custody and at least three suspects are wanted after a jewelry store robbery in Oshawa. On Wednesday, January 21, 2026, at approximately 6:40 p.m., members of Central East Division responded to a robbery call at Oshawa Jewellery located in the Oshawa Centre at 419 King Street West. Three males

entered the mall and attended the jewelry store where they smashed display cases before fleeing with jewelry. One of the suspects was intercepted in the mall and taken into custody. The other two suspects fled the mall into a waiting vehicle. The suspect vehicle fled the area prior to police arrival.

A 13-year-old male from Hamilton is charged with: Robbery, Disguise with Intent, and Possession of Property Obtained by Crime Over \$5000.

Males Arrested After Stolen Vehicle Located in Whitby

Three male youth are facing charges after being located in a stolen vehicle in Whitby. On Saturday, January 17, 2026, at approximately 8:45 a.m., members of Central West Division were on proactive patrol when they observed a stolen Honda SUV in the area of Twin Streams Drive and Country Lane. Officers attempted to block the vehicle; however, it fled the area, hitting a police cruiser. The suspect vehicle collided with a tree a short distance away and three suspects fled the SUV on foot. Officers, with the assistance of the Remotely Piloted Aircraft System, K9 Unit, Tactical Support Unit, and Robbery Unit, located all three suspects who were taken into custody. One of the suspects was found to be responsible for a jewelry store robbery that occurred on Thursday, January 15, 2026, at the Peoples Jewellers located in the Shops at Pickering City Centre, as well as an attempted robbery that occurred on Thursday, January 15, 2026, at Oshawa Jewellery located in the Oshawa Centre. This investigation is ongoing.

A 16-year-old male from Whitby is charged with: Possession of Property Obtained by Crime Over \$5000 x3, Disguise with Intent x3, Fail to Stop for Police, Dangerous Operation, Leave Accident Scene, Robbery, Attempted Robbery, and Possess Weapon Dangerous x2. He was held for a bail hearing.

A 14-year-old male from Whitby is charged with: Possession of Property Obtained by Crime Over \$5000, and Disguise with Intent. He was released on an Undertaking.

Suspects Wanted After Armed Robbery in Pickering

At least three males are wanted after an armed robbery at a department store in Pickering. On Monday, January 19, 2026, at approximately 7:30 a.m., members of West Division responded to a robbery call at the Wal-Mart located at 1899 Brock Road. Three males caused property damage and stole electronics before fleeing to a waiting vehicle. All suspects fled the area prior to police arrival.

Male Arrested Following Firearm Investigation in Bowmanville

A male is facing several firearm charges after an investigation by the Gun and Gang Unit in Bowmanville. On Wednesday, January 21, 2026, members of the DRPS Gun and Gang Unit (GGU) completed a firearm investigation and executed a search warrant at a residence in the area of Green Road and Baseline Road. A search of the residence located a handgun, three prohibited overcapacity magazines, ammunition, and drugs.

Nicholas Alexander RILEY, age 28 from Bowmanville is charged with: Possess Loaded Restricted/Prohibited Firearm, Possess Prohibited/Restricted Device x3, Possession of Schedule I Substance for the Purpose of Trafficking (cocaine), Possession of Schedule I Substance for the Purpose of Trafficking (percocet), Possession Contrary to Order, Fail to Comply with Probation Order x2, and Fail to Comply with Release Order x3.

At the time of his arrest, the suspect was bound by probation and release orders.

Suspects Wanted After Jewelry Store Robbery in Pickering

Police are searching for at least four suspects after a jewelry store robbery at the Shops at Pickering City Centre. On Thursday, January 15, 2026, at approximately 5:35 p.m., members of West Division responded to a robbery call at Peoples Jewellers located in the Shops at Pickering City Centre at 1355 Kingston Road. Four masked suspects entered the jewelry store began smashing display cases. The suspects stole a quantity of jewelry before fleeing the mall in a vehicle.

Two drivers are being treated for serious injuries following a head on collision in Scugog

On Monday, January 12, 2026, at approximately 5:00 p.m., members of North Division responded to a collision in the area of Lake Ridge Road and Blue Mountain Road. A Ford hatchback was travelling southbound on Lake Ridge Road when it collided head-on with a Nissan SUV travelling northbound. Both drivers suffered serious injuries and had to be extricated from their vehicles. One driver was airlifted to a Toronto-area trauma centre where he remains in stable condition. The other driver was transported to a local-area hospital.

Two males are facing charges after fleeing a R.I.D.E. line in Oshawa

On Monday, January 12, 2026, at approximately 11:00 p.m., members of Central East Division were conducting a R.I.D.E. initiative in the area of Stevenson Road and Gibb Street. A driver was instructed by officers to pull off the roadway after they showed signs of impairment. The driver then fled from the R.I.D.E. line at a high rate of speed. A short distance away, the suspect vehicle struck another motorist but continued fleeing at a high rate of speed. When officers attempted to contain the vehicle, it intentionally struck two police cruisers before continuing to evade police. The vehicle was then operated in a dangerous manner for several more blocks until the driver and passenger abandoned it and fled on foot. Officers, with the assistance of the K9 Unit and the Remote Piloted Aircraft System (RPAS), tracked the suspects on foot and located them a short distance away hiding in a residential backyard, where they were taken into custody.

Je'veon HAMBLETT-OXLEY, age 29 from Oshawa is charged with numerous offences including: Dangerous Operation, Fail to Stop for Police, Fail to Remain at Accident, Possession of Schedule I Substance (oxycodone), and Care or Control of Vehicle with Cannabis Readily Available.

Lincoln RICHARDS, age 32 from Oshawa is charged with: Possession of Schedule I Substance, and Care or Control of Vehicle with Cannabis Readily Available. **HAMBLETT-OXLEY** was held for a bail hearing.

Male and Female in Custody After Stolen Vehicle Investigation

A male and female are in custody after a stolen vehicle investigation located several stolen vehicles in Pickering. In late December, 2025, investigators received information about a stolen vehicle believed to be on a residential property in Pickering. Members of the West Division Criminal Investigations Branch, Auto Theft Unit, and Community Response Unit executed a search warrant and located several stolen and re-vinned vehicles. A male and female suspect were taken into custody without incident.

Kevin BERRY, age 50 from Pickering is charged with: Possession of Property Obtained by Crime Over \$5000, and Possession of Property Obtained by Crime for the Purpose of Trafficking Over \$5000 x2.

Shannon Marie LEYNES, age 44 from Pickering is charged with: Possession of Property Obtained by Crime Over \$5000, and Possession of Property Obtained by Crime for the Purpose of Trafficking Over \$5000 x2.

Male Arrested After Armed Robberies in Clarington

A male is in custody after committing multiple armed robberies in Clarington and Bowmanville. On Saturday, December 13, 2025, at approximately 8:15 p.m., a male entered the Circle K located at 180 King Street East in Clarington, and demanded cash while armed with two large knives. On Saturday, January 3, 2026, at approximately 6:10 p.m., the suspect entered the Liberty Best Variety located at 83 Liberty Street South in Bowmanville, and demanded cash while pointing a firearm at an employee. On Monday, January 5, 2026, at approximately 8:50 p.m., the suspect re-attended Liberty Best Variety, and demanded cash while pointing a firearm at an employee. The suspect attempted to flee but was taken into custody a short distance away. The firearm was determined to be an imitation handgun. A 15-year-old male from Clarington is charged with: Robbery x3, Disguise with Intent x3, Point Firearm x2, Possess Weapon for Committing Offence x3, and Possession of Proceeds Obtained by Crime Under \$5000 x2.
