Ontario Protecting Families by Holding Impaired Drivers

The Ontario government is developing new measures that would require impaired drivers to pay ongoing child support if they kill a child's parent or guardian. The initiative would build on recent measures passed in the Roads Safer and Communities Act, 2024, and is part of the government's ongoing work to protect Ontario families and communities by holding impaired drivers accountable for their reckless and illegal behaviour. These financial support measures would build on existing liabilities for

the ability of victims' families to sue impaired drivers in civil court.

"No child should have to bear the weight of losing a parent to impaired driving," said Attorney General Doug Downey. "The devastating impact reaches far beyond the immediate loss—it can leave children struggling emotionally and financially. That's why our government is looking at practical solutions that can ease their burden in the wake of such tragedies and provide financial stability for children who are left behind."

Accountable Impaired driving is illegal, America for impaired the control of the preventable and the leading cause of death on Ontario roads. In 2021, there were 182 fatalities caused by impaired driving. This includes 96 drinking and driving fatalities and 86 fatalities due to drugs.

"When a drunk driver takes an innocent life, it imposes a life sentence on the family left behind, especially the children who are suddenly without a parent," said Prabmeet Sarkaria, Minister of Transportation. "Ontario already has some of the toughest penalties in North America for impaired and reckless driving. Under the leadership of Premier Ford, we are taking another step to strengthen support for victims and their families."

In 2023, Texas introduced a similar requirement that impaired drivers convicted of "intoxication manslaughter" who have killed a child's parent or guardian pay child support until the child turns 18 or graduates high school. The province will be exploring this requirement and other examples as it considers the best way to effectively implement this proposal and hold impaired drivers accountable.

This policy proposal is part of an upcoming legislative package that will support the government's work to hold criminals accountable and support victims of

Impaired driving means operating a vehicle while the ability to do so has been compromised to any degree by a substance such as alcohol or drugs.

The Safer Roads and Communities Act, 2024 introduced a lifetime licence suspension for anyone convicted of impaired driving causing death under the Criminal Code.

Dear Premier Ford and Mayor Chow. As an elected official in this province, I am compelled to express my strongest objection to the decision to raise the Palestinian flag at Toronto City Hall today. This action is not merely inappropriate — it is a profound failure of judgment and a serious breach of responsibility to the Canadian people.

alignment. To do so now, in the face of open hostility toward Canada, is reckless and unacceptable.

You have a duty — we all do - to defend the integrity of this country, the unity of its people, and thebsanctity of our national identity. Government buildings must never be used to legitimize, normalize, or embolden extremist rhetoric or foreign political agendas.

I am urging you both to reconsider this path immediately. This decision undermines public confidence, weakens national unity, and sets a dangerous precedent for the future.

Today's decision is a dangerous betrayal of Canadian values, Canadian unity, and Canadian sovereignty.

It sends exactly the wrong message at exactly the wrong time.

I am calling for immediate reconsideration of this divisive and irresponsible action, and I urge all elected officials to defend Canadian identity, Canadian institutions, and the safety of Canadians first.
