# Pickering Council to spend \$1mn on new skateboard park

Pickering Council has approved the Request for Proposal (No. RFP2025-13) for the design and construction of a new community-sized skateboard park, as submitted by Radius Skateparks, in the amount of \$943,550 (HST included). The total project cost of \$1,064,460.00 includes the proposal amount, a contingency and other associated costs, and will be funded through the capital budget and transfers from both the Development Charges City Share Reserve and the Development Charges Parks & Recreation Reserve Fund. Pickering Council recently approved a \$266 million recreation and library complex at Seaton. The new skatepark will be built within the hydro corridor, north of Diana, Princess of Wales Park. As part of this project, the existing skateboard park in Diana. Princess of Wales Park will be demolished and the site restored, said a city notice. It said the city will enter into an amended licence agreement with Hydro One Networks Inc. to include the hydro corridor lands north of Kingston Road that will be necessary for the new skateboard park, parking, and amenities.

## Green light for two housing developments in Clarington

The Municipality of Clarington has announced that council has approved two new housing developments — one in Bowmanville and one in Courtice. The development in Bowmanville is a 7-unit, three-storey apartment building located at 53 Liberty Street North.

The Courtice project comprises six single detached homes and a future medium-density block located at 1824 Nash Road in Courtice.

Clarington Council has approved a Zoning By-law Amendment Application to facilitate a 7-unit, 3-storey apartment building in Bowmanville.

That Zoning By-law Amendment application was submitted by North Lakes Developments.

Clarington Council also approved a Zoning By-law Amendment to permit six Single Detached Dwellings Fronting onto the Extension of Tabb Avenue and a Medium Density Block Fronting onto Nash Road in Courtice.

The application was submitted by Headgate Developments Inc.

The municipality said once all conditions contained in the Clarington Official Plan and Zoning By-law 84-63 are met, the by-law authorizing the removal of the (H) Holding Symbol will be approved by the Deputy CAO of Planning and Infrastructure Services for both the projects.

The municipality said both developments align with Clarington's Official Plan and the 2024 Provincial Planning Statement, which encourages municipalities to create healthy, safe, and livable communities through diverse housing options and efficient land and infrastructure use.

## City portion of Oshawa 2026 tax may go up by 4.68%

The City of Oshawa claims it has pared down the projected increase in its portion of the 2026 tax levy to 4.68 per cent. The final budget will need to be approved by council.

Oshawa's operating budget required a tax levy increase of 7.87 per cent in 2025.

Of all revenue sources, property taxation including the 2026 proposed increase, makes up 77.3 per cent, the city said.

"The city, in 2024, prepared a multi-year forecast for 2026 projecting a 5.36 per cent tax levy increase on the Oshawa portion of the tax bill. As part of the 2026 city budget process, the city implemented an extensive review and incorporated best practices including identification of synergies across departments, revenue maximization, cost containment, budget right-sizing and adaptive procurement strategies to counter increasing costs, supply chain issues and impacts of potential tariffs.

"These strategies resulted in the tax levy impact decreasing from the forecasted 5.36 per cent to 4.68 per cent," said the city's budget document.

It says the 2026 budget submission requires a \$8.73 million increase in the tax levy over the 2025 approved budget. This represents a 4.68 per cent tax levy increase on the Oshawa portion of the tax bill.
