

THE RONA FOUNDATION’S HOME SWEET HOME CAMPAIGN WILL RAISE FUNDS TO SUPPORT TWO ORGANIZATIONS IN THE DURHAM AREA

The RONA Foundation, which oversees the philanthropic activities of RONA inc., one of Canada's leading home improvement retailers, operating and servicing over 425 corporate and affiliated stores, is launching the Home Sweet Home campaign today, marking its fourth consecutive year.

The Durham Regional Police Service responds to thousands of domestic-related incidents annually (for example, responding to over 7,700 incidents in a recent year, representing a 7% increase).

According to data shared by the Durham Regional Police Service and national figures, about 44% of women and 33% of men in Canada experience some form of intimate partner violence in their lifetimes.

If you can donate. Do not hesitate and help if you can. It is not just a social problem it is a people problem.

Through this initiative, teams across the RONA network will mobilize to raise funds in support of nearly 150 non-profit organizations (NPOs) throughout Canada.

From August 31 to October 12, 2026, a fundraising campaign will be held in all RONA+ and RONA corporate stores, as well as some distribution centres and participating stores in RONA's affiliated dealer network.

Funds raised will be used to support organizations that provide aid to victims of domestic violence, low-income families and individuals with special needs or mental health issues.

Since it was created in 2023, the Home Sweet Home campaign has donated close to \$2M to hundreds of NPOs across Canada.

In the Durham area, the local RONA and RONA+ stores will collect donations for two (2) local organizations.
