Female Arrested for Sexual Assault at Group Home in Oshawa

A female staff member is facing charges following an investigation into sexual assaults that occurred at a group home in Oshawa.

In February 2026, investigators with the DRPS Special Victims Unit began an investigation into a female staff member who reportedly sexually assaulted a 13-year-old male several times at a group home in Oshawa. Further investigation revealed that between September 2025 and January 2026 the suspect engaged the victim in a sexual relationship.

On Wednesday, June 24, 2026, investigators concluded their investigation and took the suspect into custody without incident.

Police have concerns there may be further victims.

Shari Shoshana MCGREGOR, age 30 from Clarington is charged with: Sexual Assault, Sexual Interference, and Invitation to Sexual Touching.

Male Arrested After Pointing Firearm During Road Rage Incident in Oshawa

A male is facing charges after pointing a firearm at another male during a verbal road rage altercation in Oshawa.

On Wednesday, June 17, 2026, at approximately 5:05 p.m., members of Central East Division responded to an armed person call in the area of Ritson Road North and Taunton Road East. The suspect and victim were involved in a verbal road rage altercation when the suspect pointed a firearm toward the victim and made threats, before leaving the area. Officers arrived on scene and quickly located and arrested the suspect without incident. The firearm was later confirmed to be an imitation pistol.

The victim did not suffer any physical injuries.

Bhaviya Jiteshkumar PATEL, age 26 from Clarington is charged with: Point Firearm, Assault with a Weapon, and Weapons Dangerous.

Male Arrested for Failing to Comply with Release Order

A 43-year-old male has been charged with failing to comply with his court-imposed release order after being convicted of sexual offences against a child.

On Monday, June 22, 2026, members from East Division received information that a male was breaching his conditions. Through investigation, officers confirmed that the male is bound by a court-

imposed order, which prohibits him from being in the company of or communicating with anyone under 16-years-of-age. Officers were able to confirm the male violated this order and he was arrested without incident.

Alexander BROOKING, age 46, of Oshawa is charged with Fail to Comply with Release Order.

Male Arrested for Bank Fraud in Oshawa

A male is facing charges after attempting to fraudulently open bank accounts at multiple banks in Oshawa.

On Friday, June 19, 2026, at approximately 1:25 p.m., members of Central West Division responded to a fraud call at the Scotiabank located at 2630 Simcoe Street North. A male attended the bank and attempted to open an account using fraudulent identification. Officers arrived on scene and took the male into custody without incident.

Kyle Ryan CABRAL, age 39 from East Gwillimbury is charged with: Fraud Under \$5000, Possess Identity Document of Another x3, Utter Forged Document, Fail to Comply with Probation Order x2, Personation to Gain Advantage x2, and Obtain Identity Information for Fraudulent Offence.

Two Arrested after Armed Home Invasion in Ajax

Two males are in custody following an armed home invasion and drug trafficking investigation in Ajax.

On Tuesday, February 3, 2026, at approximately 3:30 a.m., members of West Division responded to an armed person call at a residence in the area of Kingston Road West and Westney Road North. Residents of the home contacted police after two suspects broke into their residence armed with handguns. The suspects fled in a vehicle prior to police arrival. Investigators identified two suspects and on Thursday, June 18, 2026, the West Division Crime Team, with the assistance of the DRPS Tactical Response Unit, Community Response Unit, East Division Crime Team and Intelligence Unit, executed search warrants at five locations in Durham and Toronto.

During the search warrants, officers seized a firearm with two over capacity magazines, several rounds of ammunition, a quantity of drugs, including cocaine, fentanyl and methamphetamine, and various Schedule I pills. They also seized a large quantity of Canadian currency.

Two males have been arrested and are facing multiple charges.

from Mississauga is charged with: Possess Restricted Firearm Knowing Possession Unauthorized; Point Firearm x2; Occupy Motor Vehicle with Firearm; Robbery with Firearm; Possess Firearm while Prohibited; Possess Ammunition Contrary to Order; Possession Methamphetamine for the Purpose of Trafficking; Possession Cocaine for the Purpose of Trafficking; and Possess Other Sched I for the Purpose of Trafficking; Possess Property Obtained by Crime.

At the time of his arrest, FOFILZEH was on a weapons prohibition and an order not to possess any ammunition.

Ahmed ALI, age 30 from Oshawa is charged with: Possess Restricted Firearm Knowing Possession Unauthorized; Possession of a Prohibited Device or Weapon x3; and Possess Cocaine for the Purpose of Trafficking.

Two Arrested for Prescription Fraud in Oshawa

Two males are facing charges after committing prescription fraud at multiple pharmacies in Oshawa.

On Friday, June 19, 2026, at approximately 2:00 p.m., members of Central East Division responded to a fraud call at the pharmacy inside of the Real Canadian Superstore located at 481 Gibb Street. A male attended the pharmacy and attempted to fill a prescription with fraudulent doctor's documents. The suspect left the area in a waiting vehicle prior to police arrival.

A short time later officers located the suspect vehicle at a second pharmacy in the area of King Street West and Stevenson Road South. Two suspects were found in the vehicle and taken into custody without incident. A search of the vehicle located fraudulent medication prescription documents and a large quantity of prescription medications valued at over \$15,000.

Mohamed OUDHA, age 26 from Montreal is charged with: Fraud Under \$5000, Utter Forged Document, and Possess Property Obtained by Crime Over \$5000.

Mohamed BOULFRED, age 39 from Montreal is charged with: Fraud Under \$5000, Utter Forged Document, Possess Property Obtained by Crime Over \$5000, and Breach Probation.

Male Arrested After Break-and-Enter and Theft Investigation in Whitby

A male is facing charges following a break-and-enter and theft investigation in Whitby.

On Saturday, May 30, 2026, members of Central West Division responded to a break-and-enter call at a residence under construction in the area of Thornton Road North and Conlin Road West. A male suspect entered the residence and stole several appliances, residential wiring, and construction equipment. On Wednesday, June 10, 2026, members of Central West Division responded to a second call for a break-and-enter at the residence. Officers searched the residence and found evidence the suspect had been staying in the home while it was undergoing renovations.

Further investigation located several of the stolen appliances for sale on Facebook Marketplace.

On Saturday, June 13, 2026, the suspect was located in Oshawa with a stolen air conditioning unit and taken into custody without incident. A search warrant was later executed at the suspect's home where several stolen appliances were located.

Jesse Kevin POTTS, age 33 from Oshawa is charged with: Break-and-Enter x2, and Possession of Property Obtained by Crime Over \$5000.

Two Arrested for Stolen Vehicle in Oshawa

A female adult and female youth are facing charges after being found in possession of a stolen vehicle in Oshawa.

On Sunday, June 21, 2026, at approximately 8:10 p.m., members of Central East Division on proactive patrol located a stolen Dodge minivan in the area of Glen Street and Porter Street. Officers approached the Dodge and found a youth and adult female in the vehicle. Both females were taken into custody without incident. A search of the vehicle located two imitation firearms.

The stolen Dodge is linked to several other incidents including: dangerous operation of a vehicle, mischief, and assault with a weapon, where the occupants discharged a bb-style gun at the victim. These investigations are ongoing.

Brooklynn NOSEWORTHY, age 18 from Oshawa is

charged with: Possess Property Obtained by Crime Over \$5000.

A 14-year-old female from Oshawa is charged with: Possess Property Obtained by Crime Over \$5000.

NOSEWORTHY was released on an Undertaking. The 14-year-old female was released on a youth diversion.

Male Charged with Power of Attorney Fraud and Theft in Whitby

A male acting as Power of Attorney for a 95-year-old male is facing charges after fraudulently transferring over \$900,000 into his personal account.

In April 2025, members of the DRPS Older Adult Support and Investigative Services Unit began an investigation into a male suspect after it was reported that he was fraudulently transferring funds from the victim's account while acting as Power of Attorney. Investigators determined the suspect had transferred over \$900,000 in funds from the victim's account without the victim's knowledge or consent.

On Monday, June 22, 2026, investigators concluded their investigation and took the suspect into custody without incident.

Both the suspect and victim are known to each other. The identity of the accused is being withheld to protect the identity of the victim.

A 62-year-old male from Whitchurch-Stouffville is charged with: Theft by Person Holding Power of Attorney, Theft Over \$5000, and Possess Proceeds of Property Obtained by Crime Over \$5000.

Female Arrested for Identity Fraud at Bank in Clarington

A female is facing charges after attempting to fraudulently open a bank account in Clarington.

On Thursday, May 28, 2026, at approximately 2:40 p.m., members of East Division responded to a fraud call at the Scotia Bank located at 1500 Regional Highway 2. A female was at the bank attempting to open an account using a fraudulent driver's licence. Officers arrived on

scene and took the suspect into custody without incident.

The suspect had reportedly attempted to open an account at a different bank earlier that morning, using fraudulent identification, but was refused.

Alicia Dawn MILLER, age 41 from Toronto is charged with: Possess Identity Document of Another, Utter Forged Document, and Fraud Under \$5000.

Male Wanted for Counterfeit Currency Fraud at Oshawa Centre

Police have issued a warrant for a male who attempted to use counterfeit currency to make purchases at the Oshawa Centre.

On Friday, March 20, 2026, at approximately 7:20 p.m., members of Central East Division responded to a fraud call at the Oshawa Centre located at 419 King Street West. A male attended various businesses and attempted to use fraudulent currency to purchase items. Mall security attempted to stop the suspect; however, he fled the area on foot.

Liam Dylan BRAMLEY-MONTGOMERY, age 30 from Oshawa is wanted for: Fraud Under \$5000 x3, Utter Counterfeit Currency x3, and Breach Probation.

Fatal Motorcycle Collision in Ajax

One male has died following a motorcycle collision in Ajax.

On Thursday, June 26, 2026, at approximately 3:45 p.m., members from West Division responded to collision involving a motorcycle and motor vehicle in the area of Harwood Avenue North and Kerrison Drive East.

A grey/silver Honda motorcycle was travelling southbound on Harwood Avenue North approaching Kerrison Drive East. A black Chevrolet Malibu was travelling northbound on Harwood Avenue North and turned left into the path of the motorcycle.

The 34-year-old male motorcyclist was taken to a local area hospital with life-threatening injuries, where he was later pronounced deceased. The driver of the Malibu remained on scene and is cooperating with police. There were no other injuries.
