FLMHAC's History

- Originated as "The Advocacy Project" with 2-year grant from Allegany Franciscan Ministries to NAMI Palm Beach County.
- Began as two NAMI advocacy groups in Broward and Palm Beach County.
- Advocacy group leaders recruited and trained from different areas of the state.
- Registered as a 501(c)4 in 2020.
- Part-time lobbyist hired.
- Coalition grew quickly with new member organizations.

- Organize: meet biweekly/weekly; decide on actions
- **Educate:** meet legislators, decision-makers
- Collaborate: partner with other state orgs
- Participate: join committees, local task forces, Behavioral Health Day in Tallahassee





2023 Top Three Legislative Priorities

- 1. Funding and coordination for the successful implementation of 9-8-8
- 2. Funding to develop more supportive housing for individuals living with serious mental illness
- 3. Integration of behavioral health care with primary health care



9-8-8: Our First Priority


- New nationwide phone number for suicide prevention and behavioral health crises
- Created by S.2661, the National Suicide Hotline Designation Act of 2020.
- Activated July 16, 2022.
- Calls to Florida's 13 National Suicide Prevention Lifelines (NSPLs).

An Alternative to 9-1-1

- Most behavioral health emergencies handled by 9-1-1 and law enforcement.
- 9-1-1 call-takers and responders may not understand behaviors of people with developmental disabilities and/or mental illness
- 9-1-1 makes mental illness a criminalized experience
- Often results in trauma and even death
- CIT training critical but not enough





The Promise of 9-8-8


- A new number to call for emergencies dealing with mental health or substance use
- A game-changer for families and individuals
- Potential to save years of trauma and lack of treatment
- Potential to relieve police of ~20% of response





9-8-8 as a Portal to Access Behavioral Health

- National movement to reimagine a more effective access system to care as part of 9-8-8
- Help increase access to a confusing system of care
- 9-8-8 as an easy-to-access portal into the behavioral health system
- Model crisis response programs already operating around the country







The Three Pillars of Effective Crisis Response

Where is Florida Now with 9-8-8?

- 9-8-8 activated statewide July 16, 2022
- Call data available for July 2021-August 2022:
 - 47% increase in incoming calls
 - 25% DECREASE in answer rate (from 77% to 58%)
- Florida has the lowest in-state answer rates of all states

Status of Funding for 9-8-8

- Call centers submitted budgets to DCF in 2022 estimating costs of expansion to meet call volume:
 - Year 1: \$25.2M
 Year 2: \$29.4M
 Year 3: \$33.2M
- Federal funds received from SAMHSA \$5.2M, minus administrative costs = \$4.5M over 2 years, through 6/30/24
- Federal funds via the supplemental Mental Health Block Grant = \$8.4M to call centers 22-23 and 23-24 (ends 6/30/24)
- Other states have passed legislation approving telecommunications fees to support 9-8-8 operations
 - Nevada, Washington, Colorado, California and Nevada

FLMHAC Activities around 9-8-8

- Drafted legislation in 2021 SB478 sponsored by Sen. Jason Brodeur
- Educate legislators and state officials to promote 9-8-8
- Make presentations around the state, virtually and in person (20+ so far)
- Disseminate information by flyers, social media, videos, email blasts
- Participate in 9-8-8 Planning Coalition
- Lead the 9-8-8 State Advocacy Coalition
- Participate in NAMI national 9-8-8 advocacy group




Commission on Mental Health and Substance Abuse

- 19-member Commission formed by state legislature in 2021
- Studying how behavioral health system can be improved
- Make recommendations to Governor, Senate and House
- Working on first report
- Last Commission met in 2001 result was Managing Entity system
- MAJOR changes will be recommended
- Meetings live-streamed and open to public
- FLMHAC has five members serving on Subcommittees
