1. SEASON COMMITMENT

I understand that enrollment on the LionHeart Stables IEA Team is a commitment for the entire 2026–2027 IEA season.

2. COMPETITION COMMITMENT

Junior and High School riders are expected to attend the five regular season shows. Adult riders are expected to attend the Adult Team competitions once the IEA releases the official schedule. Hosting responsibilities and team expectations apply to all teams.

3. TUITION & PAYMENT

Annual team tuition is \$1,375. Payment in full or an approved payment plan is required. A payment plan does not reduce the obligation to pay the full tuition.

4. NO REFUND POLICY

I understand that tuition is non-refundable after enrollment, including if the rider withdraws, misses practices or competitions, changes interests, or has scheduling conflicts, except where required by applicable law.

5. WEEKLY LESSONS

A lesson package is required throughout the season, with a minimum of four lessons per month. Team practices supplement, but do not replace, regular lessons.

6. TEAM EXPECTATIONS

I agree to follow the LionHeart Stables IEA Team Guide, demonstrate good sportsmanship, respect coaches, volunteers, teammates, and horses, and participate in required hosting and volunteer responsibilities.

- ☐ A two-payment plan spreads the cost; it does not reduce the total owed. Tuition is non-refundable after enrollment.
- ☐ Payments not received within 5 days of the due date may result in a \$25 late fee. An account more than 10 days past due may hold the rider from show entries until it is current.
- ☐ Withdrawal does not cancel the second payment. A bundled apparel package is ordered once the first payment clears.
- ☐ Tuition covers one class per show. Jumping-division riders ride two classes; the second is \$65, billed per show as entered.

I agree not to bring any suit or other legal proceeding against the Company or any of its agents, servants or employees for any personal injury or property damage experienced by me or others occurring on or about the Premises or elsewhere, or arising in connection with any Activities except for claims arising from the willful and malicious misconduct of an employee of the Company. I further assume full responsibility and liability for the conduct and safety of any minor brought by me to the Premises or Activities, or left at the Premises or Activities under my supervision.

I hereby release and hold harmless the Company from, agree to defend, and indemnify the Company against any and all claims for personal injury or property damage arising out of or relating to my presence upon the Premises or my participation in or observation of any Activities.

I will pay all costs and attorneys' fees arising from any suit or legal proceeding which is brought by me contrary to the terms of this document, and which is resolved or determined in favor of the Company.
