- c. Federal Dollars are still in a resolution. If passed it should be an increase from last year, however it is unknown
- d. Gary Gunther will be moving into the position of Housing Director for Upper Shore Aging. Board of Directors is in process of selecting a new Director and should have someone appointed by next months meeting
- e. Budget request to County Council was made yesterday to include \$83,000 additional funds
