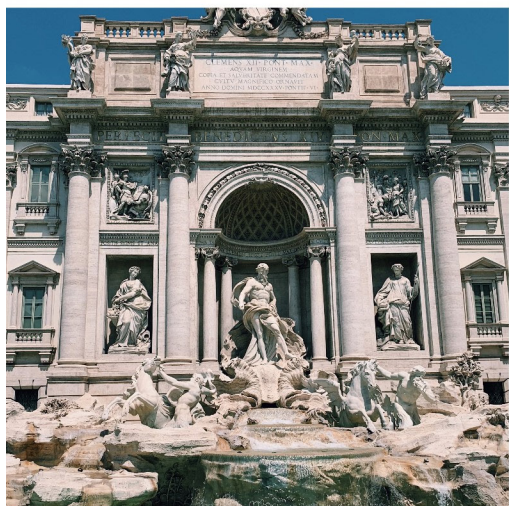
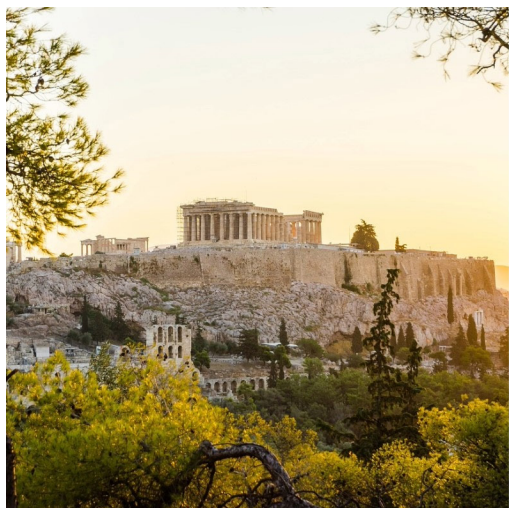


Journeys of Paul & John in Greece & Rome *including a 4-night Aegean cruise* *May 17 - 28, 2024* *with Dr. Brent Taylor*



DAY 1, FRI, MAY 17 **DEPART USA**
Depart on our overnight flight to Greece. (meals aloft)

DAY 2, SAT, MAY 18 **ARRIVE ATHENS**
Today we arrive in Athens and are met by our guide. We board our coach and transfer into the city where we check into the **Athens Avenue Hotel** with some time to rest and freshen up. Dinner is included at the hotel this evening. (meals aloft,D)

DAY 3, SUN, MAY 19 **ATHENS**
We spend the full day touring Athens. First we visit the Acropolis with the Parthenon shimmering in its ageless grace and unmatched design, and the unique Erechtheion (the only double temple). Nearby we climb the Areopagus (Mars Hill), where Paul addressed the philosophic court about Jesus and the resurrection (Acts 17:22-34). We walk through the remains of the Agora, the marketplace that served as the political and social heart of ancient Athens. Our sightseeing also features a panoramic tour to view Embassy Row, the Tomb of the Unknown Soldier, the National Palace, the House of Parliament, and the University. Later today we return to our hotel for dinner and overnight. (B,D)

DAY 4, MON, MAY 20 **ATHENS/MYKONOS**
This morning we board our cruise ship, the *Celestyal Olympia*. We arrive in the afternoon at the world famous Greek island of Mykonos. Mykonos combines the dazzling white beauty of a typical Cycladic island with a sophisticated jet-set atmosphere. Stroll at leisure through the white-washed, flower-decked alleyways to the church of Paraportiani, and along the waterfront to the famous windmills. (B,L,D)

DAY 5, TUE, MAY 21 **EPHESUS/PATMOS**
We arrive this morning at Kusadasi, Turkey and journey to Ephesus, which had become the capital city of the Roman Province of Asia by the time John wrote the Book of Revelation to the churches there. Walk through history in a city founded as early as the 10th century B.C. and in the magnificent excavations see streets lined with wonderful public buildings such as the Baths of Scholastica, the Library of Celsus, the Temple of Hadrian, the Basilica of St. John and the great theatre. We then sail to the former Roman prison island of Patmos where John received his "Revelation." Here we visit the Grotto named for his book and the Monastery of St. John which houses ancient manuscripts including one of the Gospel. (B,L,D)

DAY 6, WED, MAY 22 **RHODES**
The Colossus of Rhodes, one of the Seven Wonders of the Ancient World, once dominated the strategic harbor entrance. Later it served as a crucial outpost for the Crusaders in many of their ill fated journeys to Israel during their conflicts with the Muslim conquerors.

Today we visit Lindos and climb to the top of the ancient acropolis standing 122 meters above the sea, overlooking St. Paul's Bay. Enjoy some free time in Lindos village and then return to Rhodes city. Return to the ship for lunch, or dine on your own in town. Enjoy the afternoon in Rhodes to explore on your own, perhaps to view its fortifications, the Street of the Knights with medieval stone mansions, the Palace of the Grand Master and the Hospital of the Knights (now a museum). There are also art shops as well as many lovely beaches. (B,L,D)

DAY 7, THU, MAY 23 **HERAKLION/SANTORINI**
The largest of the Greek islands, Heraklion (Crete) is well-known for its archaeological sites. You may wish to take an optional excursion to the Palace of Knossos, the residence of the ruling house and also an administrative and religious center for the whole region. The buildings (a labyrinth complex) covered an area of 22 square miles. The high standard of Minoan civilization 4000 years ago, displayed here through architecture, frescoes and the perfect plumbing system, surprise modern visitors. We travel on to the island of Santorini, widely considered to be the lost continent of Atlantis. Off the entrance of the bay of Santorini there is the only active volcano in the Eastern Mediterranean. After you have strolled through the narrow streets you can enjoy the fascinating and marvelous sunset. (B,L,D)

DAY 8, FRI, MAY 24 **CORINTH/ATHENS/ROME**
This morning we disembark and drive to Corinth, the capital of the Roman province of Achaia and the city of Paul's extensive personal ministry and challenging letter writing. Dominated by the Acro-corinth rising 1700 feet above the ruins, the Market Place is still laid out as it was in Paul's day with its stone Bema (judgment dais) where Gallio refused to condemn Paul (Acts 18). Nearby in a prominent place is the Temple of Apollo with its Doric columns. A superb collection of Corinthian artifacts greets the visitor in the museum. From there we transfer to the Athens airport for our flight to Rome. Upon arrival we are met at the airport and transfer to the **Hotel Una Deco Roma** for dinner and overnight. (B,D)

DAY 9, SAT, MAY 25 **ROME**
This morning we begin at Tre Fontane, traditional site of Paul's beheading. Then we go to the Basilica of St. Paul Outside the Walls, one of the four great ancient basilicas of Rome and built over what was believed to be the burial place of St. Paul. We continue from there to St. Sebastian's, Rome's largest system of catacombs, named for the 4th century martyr originally buried here. The bodies of the apostles Peter and Paul were said to have been buried here for some time. From there we go to the Holy Stairs, or Scala

Sancta, thought to be the staircase that once led to the praetorium of Pilate in Jerusalem. According to tradition, these were brought from Jerusalem to Rome in the 4th century by St. Helena and may only be ascended on one's knees. Also this afternoon we see Piazza Navona, one of Rome's most beautiful squares, and famed Trevi Fountain. Enjoy the rest of the day at leisure, with dinner on your own this evening. (B)

DAY 10, SUN, MAY 26

ROME

Today we visit the Colosseum, begun about AD 72, and the best-known structure remaining from ancient Rome. It was capable of holding more than 50,000 to view gladiatorial contests, hunts, mock naval battles and perhaps Christian sacrifices. Many of the materials from this magnificent edifice were later used in the construction of various churches and palaces. From there we go to Palatine Hill, the centermost of the Seven Hills of Rome and one of the most ancient parts of the city. From one side it looks down upon the Forum, and from the other side, the Circus Maximus. We take a break for lunch (on your own) and then spend some time exploring the Roman Forum, the center of political life and commerce in ancient Rome. We visit Mamertine Prison, traditionally believed to have imprisoned the apostles Peter and Paul. This evening we enjoy dinner together at a favorite local *trattoria*. (B,D)

DAY 11, MON, MAY 27

ROME

Today we tour historical Vatican City. We explore the Vatican museums, one of the most renowned and famous cultural institutions of the Holy See, known all over the world for its masterpieces that have been commissioned, collected and preserved in time by the Roman Pontiffs. An unforgettable highlight is a visit to the epic Sistine Chapel, over which Michelangelo labored for four years and which has been restored to its original glory. We also visit the Basilica of St. Peter, the largest church in the world, said to be buried over the tomb of Saint Peter. After our time here, we return to our hotel. Dinner is included this evening. (B,D)

DAY 12, TUE, MAY 28

ROME/USA

We transfer to the airport for our return flight to the USA. (meals aloft)

All sites listed in the itinerary will be covered but the sequence and days may be altered to adjust to religious holidays, special closings of sites, air schedules, etc. Hotels listed subject to confirmation. This tour is not recommended for those who have mobility limitations since it includes significant amounts of rigorous walking on uneven terrain. If a passenger is unable to get on and off the bus and walk without the assistance of another individual, the passenger must bring someone with them to assist them. Please note that the Americans With Disabilities Act is not applicable outside the USA and facilities in other countries may be sharply limited.

NOT INCLUDED IN ABOVE RATE: Supplement in air fare for departure from cities other than Dallas Fort Worth. Any cruise fuel surcharge; optional shore excursions; cruise cabin upgrades; any fee imposed by the airline to reserve seat assignments; single room/cabin supplement (\$2,270 for land and cruise, based on interior cabin on cruise); meals not listed as being included; excess baggage and forwarding of baggage, passports, personal items such as laundry, tips for personal favors, Travel Protection Plan, any costs resulting from absence or deviation from the itinerary and any items not shown herein as being included.

TOUR DOCUMENTS AND ENTRY REQUIREMENTS: The name on your air ticket must exactly match your name as it appears on your passport. Please forward a copy of the photo/informational page of your passport when enrolling on the tour. If applying for a new or renewed passport, send the copy as soon as you receive your new passport. Passports must be valid 6 months past return date of travel. US citizens do not need a visa for travel to Greece or Italy. If traveling on a passport from a country that requires a visa to enter one or both countries, obtaining the visa and paying any additional fees are your responsibility.

DEPOSIT/PAYMENT: A deposit of \$500 per person is required at least 120 days prior to departure in order to confirm tour membership and can be made by check, e-check/bank transfer, or credit card. Within 120 days, space may be limited and/or a supplement in airfare may apply. Balance of tour price is due upon receipt of final invoice (approximately 10-12 weeks prior to departure). Note that there is a 4% surcharge if paying for the balance of your trip by credit card, as reflected in the tour pricing above.

DEVIATION ITINERARY: Any adjustment in standardized air or land itinerary will carry a \$100 fee (for each change) in addition to any additional expense required. This fee is applicable for research projected and/or accepted. To ensure efficient handling of these requests, Dehoney Travel, Inc. will require that a tour deposit be received before a deviation request can be processed. If deviating from the group tour program, there will be no refund for any service not used. Deviation requests must be submitted in writing to air@dehoneytravel.com. Deviation requests received within 100 days of departure may incur additional change fees from the airline and/or land provider.

AIR TRANSPORTATION: IATA Economy class, applicable on Air France or other IATA carrier. Supplement will apply for departure from cities other than Dallas Ft. Worth. Current U.S. securities, customs and departure tax, fuel surcharge and foreign departure taxes of \$687 are included in the tour rate and are subject to change prior to departure.

SEAT REQUESTS AND AIR UPGRADES: Airlines differ in their handling of seat assignments for groups. In most cases, seats are not assigned until about 3 weeks prior to departure, and occasionally seat assignments are not available until airport check-in on the day of departure. Tour price does not include any fees that may be required by the airline to secure a reserved seat assignment. Please note that specific air seat requests will be forwarded to the airline on your behalf but are subject to final approval/confirmation by the airline.

Seat requests must be submitted in writing to air@dehoneytravel.com. **Group tickets are not upgradeable.** If you wish to upgrade, your air ticket must be issued separately, which requires full payment of the ticket cost at the time the ticket is issued. **Once issued, the ticket is non-refundable and any fees resulting from changes or cancellation are at the traveler's own expense.**

HOTELS/SHIP: Tour price based on two persons in a room in twin-bedded accommodations with private bath in first-class/four-star hotels, and **standard interior cabins on cruise. Port charges of approximately \$200 are included in the tour rate.** While Dehoney Travel will try to match roommates, we cannot guarantee that a roommate will be available. In this case, the payment of single supplement will be required. When available, single rooms are often smaller than doubles. **Single supplement, \$2,270 for land and cruise, based on interior cabin on cruise.** Cabin upgrades may be available on the cruise as follows: Category XA oceanview cabin with porthole window, \$200 per person double or \$375 single. Category XB oceanview cabin with picture window, \$290 per person double or \$550 single.

MEALS AND SIGHTSEEING: As listed in the day by day itinerary (B, breakfast; L, lunch; D, dinner); breakfast daily; dinner as shown on itinerary; four lunches on board ship. Wine, beer, soft drinks, water, coffee, & tea included with all meals on board cruise. Full sightseeing with luxury buses, English-speaking guides, and entrance fees to places visited as described in the itinerary are included in the tour. **Gratuities to guides, bus drivers and hotel/ship personnel (\$150) are included in the tour rate and will be distributed on your behalf as you travel.**

LUGGAGE: Because of space limitations on buses used, we have included portage for only one check-on bag (combination width, length, and height not to exceed 62 inches and maximum weight of 50 pounds) in tour cost. You may also take one carry-on which will fit under your airline seat or in the overhead compartment.

DELAYS, CANCELLATION AND REFUND: Dehoney Travel, Inc. is not responsible for changes and delays in airline schedules and **cannot reimburse** passengers for expenses resulting from delays, re-issuance of air tickets, etc. Should you cancel, there will be a fee of \$100 for Dehoney Travel, Inc. to cover administrative costs. In addition, the following scale of charges will apply (per person) when notice of cancellation is given in writing after the booking is confirmed:

- Up to 121 days prior to departure, \$100.
- 120-61 days prior to departure, \$500.
- 60-46 days, 25% of total tour price.
- 45-31 days, 50% of total tour price.
- 30-0 days, 100% cancellation penalty.

On or after the date of departure there can be no refund for any service not used.

All cancellation notifications must be made in writing to Dehoney Travel, Inc. Please allow 4 weeks for cancellation refund processing.

After ticketing of international and domestic air, a cancellation penalty of 100% of air fare is in effect. Group tickets are normally issued approximately 30 days prior to departure, but in the event that your ticket is issued earlier, the above schedule of cancellation penalties and refund amounts will be adjusted accordingly.
