

SUBMISSION POLICY

We accept submissions throughout the year. Submissions can be related to topics related to international economic law including the WTO, trade and human rights, development, environment linkages, law and economic perspectives, international financial law, competition and antitrust issues, etc. Submissions related to the field are solicited primarily from practitioners, academicians, policy makers. Any other issue pertinent to International Economic Law will also be considered.

Articles should be 10000-12000 words in length and accompanied by an abstract and biographical information. The Harvard Blue Book citation style must be followed.

The *Law in Focus* section discusses contemporary legislations and landmark treaties which have been in focus in last few years. Submissions in this category may be 3000-5000 words.

Graduate students are encouraged to submit *Case Notes* and *Legislative Commentaries* in areas related to IEL. Submissions should mention the category and be within the word limit of 7000 words.
