American Worldwide Kennel Club, LLC (AmWWKC) will principally work for the protection and advancement of all purebred dogs. All dogs and breeders previously registered with Worldwide Kennel Club, Ltd. have been automatically registered with American Worldwide Kennel Club, LLC.

1. AmWWKC Registering Office is a separate and distinct registration office and has no connection with any other registration office. It continues the legacy of Worldwide Kennel Club, Ltd which has closed after over 50 years in business.
2. Any purebred dog, new breed or rare breed that is eligible for registration in any kennel club will be eligible for registration in AmWWKC. Evidence of eligibility for registration must be submitted. Pedigreed designer breeds will be recognized based on the pedigree of the sire and dam.
3. Limited registration is determined by breeder/owner when issuing papers. Dogs with limited registration cannot be used for breeding purposes and no litter registration may be applied. The breeder has the right to lift the limited registration to full for breeding for a fee; however, AmWWKC must be notified of the change and must have the consent of the breeder in writing in order to lift the limited registration.
4. All litter and individual dog applications will be processed within 14-21 days unless applied for RUSH SERVICE which will be processed in a minimum of one (1) working day from receipt (provided this application is in order.)
5. Prompt replies will be given to questions regarding registry problems.
6. A litter of pups must be submitted no later than six (6) months from date of birth. Any litter application submitted after puppies are six months are subject to late fees.

AmWWKC reserves the right to correct or reject for cause the any individual registration. Any misrepresentation on this application is a cause for cancellation. AmWWKC reserves the right to change any and all policies, fees, etc. without notice any time conditions warrant.
