This Declaration may be amended at any regular or special meeting of this condominium, called and convened in accordance with the Bylaws, by the affirmative vote of Voting Members casting not less than two-thirds (2/3) of those present in person in person or by proxy provided a quorum is present...

NOW, THEREFORE, the undersigned hereby certify that the following amendments to the Declaration and Bylaws are a true and correct copy of the amendments as amended by the membership.

ITEM 3. Article XIII of the Declaration, "USE AND OCCUPANCY" is hereby amended as follows:
The owner of a unit shall occupy and use his apartment unit as a single family private dwelling, for himself and the adult members of his family, and his social guests while he is residing, who may visit for 30 days per year, and for no other purpose...

One pet weighing no more than 15 lbs.shall be allowed provided that such house pets causing or creating a nuisance or unreasonable disturbance, shall be permanently removed from the property upon three (3) days written notice from the Board of Directors of the Association. Additionally such pets shall only be kept and walked upon the grounds of the Cambridge G property and owners are responsible for picking up after their pets.

ITEM 4. Article IV of the Bylaws, "DIRECTORS" is hereby amended as follows:

Section 1. Number, Term and Qualifications. The affairs of the Association shall be governed by a Board of Directors composed of seven (7) persons as provided in the Articles of Incorporation if applicable. The term of each Director's service shall extend until until the next annual meeting of the members and, thereafter, until his successor is duly elected and qualified, or until he is removed in the manner provided in Section 3 below. Notwithstanding any other provision contained in these Bylaws, as amended or in the Declaration of Condominium, as amended, all Directors shall be members of the Assocation....
