
Article \_\_\_\_\_ of the By-Laws is amended as follows:

Cambridge G Condominium Association, Inc. units numbered: 160, 163, 164, 167, 168 and 169, that have not contributed to the cost of lift shall not be required to contribute thereto until a change of ownership takes place. However, when title to said units is transferred by sale, death or in any other manner by operation of law, the amount of \$3,100,00 (Three thousand one hundred dollars and no cents) shall attach as a lien to said transferred unit until the payment of \$3,100,00 shall have been made. Said payment to be made to the Cambridge G Condominium Lift Association within 60 (sixty) days after recording the new title.

The current non-participating Cambridge G Condominium Association, Inc. units may obtain access to the use of the lift upon paying the stipulated \$3,100.00 as required by this amendment.

WE HEREBY CERTIFY that the attached amendment to the Declaration was approved by in excess 75% vote of the membership or 51% of those present in person or represented by proxy (a quorum being present) at a duly called meeting on <u>December 5, 2004</u> and does not affect the interests of the lessor of the long-term recreational lease.
