RELEASE OF LEGAL LIABILITY

In consideration of being permitted membership in the Momentum Sprint Car Tour, LLC and the right to participate in Series events (the "Events"), and to enter for any purpose in connection with the Events any restricted area (herein defined as including, but not limited to the racing surface, pit area, infield, lineup area, approach area, shut down area, and all walkways, concessions, and other areas where activity related to the Events shall take place), or being permitted to compete, officiate, observe, work for, or for any purpose, participate in any way in the Events, the Undersigned, for himself/herself, his/her personal representatives, heirs, and next of kin, Hereby Releases, Waives, Discharges, and Covenants Not To Sue Momentum Productions, LLC, the promoter, participants, racing association, sanctioning organization or any subdivision thereof, track operator, track owner, officials, pit crews, sponsors, advertisers, car owners, lessees, any person in any restricted area, and each of them, their officials, and employees all for the purpose here referred to as "Released Parties," from all liability for demands on account of injury to person (including death) or damage or loss of property of resulting participation in the Events and/or presence in the restricted area, whether such injury, death or damage caused by the negligence of the Release Parties or otherwise while the undersigned is in or upon the restricted area, and/or competing, officiating in, observing, working for, or for any purpose participating in the Events.

I UNDERSTAND THAT THIS MEANS THAT I AGREE NOT TO SUE ANY OR ALL OF THE "RELEASED PARTIES" FOR ANY INJURY RESULTING TO MYSELF OR MY PROPERTY ARISING FROM, OR IN CONNECTION WITH, MY PRESENCE AT OR PARTICIPATION IN ANY WAY IN THE EVENTS.

INDEMNITY, ASSUMPTION OF RISK HOLD HARMLESS AGREEMENT AND ACKNOWLEDGMENT

The Undersigned expressly acknowledges and agrees that participation in the activities of the Events is very dangerous and involves the risk of serious injury and/or death and/or property damage and the Undersigned further expressly agrees to assume all risk of participation in the Events.
