☐ **Lunar Quest using the Center's simulator. . . . NEW MISSION replacing Comet \$950**

A team of astronauts on the Moon must collaborate with Mission Control to avert a potential catastrophe after their lunar rover detects troubling readings below the surface. Their mission, to establish a long-term human habitat, takes a critical turn, forcing them to work together to ensure NASA 's finest hour.

▪ Comet Halley missions are designed for grades 5 and above and can accommodate groups of 16-32 people.

☐ **Expedition Mars using the Center's simulator \$950**

Our primary mission is to build a rover that will search for evidence of water on Mars. The year is 2076 and bases on the Mars surface and the largest moon, Phobos, have been established. As a crew travels towards Mars, an asteroid is spotted that may have negative consequences for human activity on Mars. The crew will determine how to deal with this issue as well as construct a rover for collecting samples, navigate the ship, examine Martian rocks, and keep the crew safe.

▪Expedition Mars missions are designed for grades 7and above and can accommodate groups of 16-32 people.

Challenger Learning Center Policies

Payment policies:

- A copy of the NYS BOCES COSER authorization form, a purchase order or a check must accompany your Registration Forms.
- **BOCES COSER information:** COSER 403 is used for Challenger Learning Center mission payment by NYS schools.
- NYS schools can get substitute reimbursement for teacher training using COSER 529.
- NYS districts outside the Cattaraugus-Allegany BOCES should check with their local BOCES about Cross-Over COSERs.
- **Payment by Purchase Order:** Purchase Orders will only be accepted for the total amount. Partial-payment purchase orders cannot be accepted and will NOT reserve your mission(s). A signed purchase order will reserve your mission(s). If your BOE/school requires a signed Purchase Order to facilitate payment, we will accept an attached or faxed purchase order and will return it with our signature promptly.
