### TAXES

- Summer taxes are due on September 14, 2023, without interest.
- Winter taxes are due on February 14, 2024, without penalty.
- If you did **NOT** mail your tax payments by SEPTEMBER 14, 2023, please call the TREASURER for updated tax amounts. You can pay in person on the final due dates at the Township Hall on the following dates:

**September 14, 2023 · December 28, 2023 · February 14, 2024 · FEBRUARY 29, 2024**

- WINTER TAXES **must be in the Treasurer's hand for the February 14, 2024 and February 29, 2024 payments.** POSTMARK'S WILL NO LONGER BE HONORED FOR THE FEBRUARY DATES. If these dates change there will be a posting at the hall or you can call 231-369-2482 to verify the dates.
- Unpaid taxes will be turned over to the Grand Traverse County Treasurer as DELINQUENT on March 1, 2024. At that time, will need to call the Grand Traverse County Treasurer for updated amounts due. **ALL CHECKS MUST BE MADE OUT TO GRAND TRAVERSE COUNTY TREASURER AFTER THE DATE OF March 1<sup>st</sup> 2024 AS THEY CAN NO LONGER ACCEPT CHECKS MADE OUT TO UNION TOWNSHIP.** You can now pay by credit card online at our web site. There is a usage fee of 2.30% not less than \$1.50. You must allow 5 days for processing of your credit card payment. They are NOT done and deposited the same day. - If you are a **disabled veteran** and qualify for the veteran's exemption, the form is on our website. **This form MUST BE COMPLETED EVERY YEAR AND MAILED TO THE ASSESSOR BEFORE THE MARCH BOARD OF REVIEW. THIS IS NOT A STANDING REQUEST. THE ASSESSOR'S MAILING ADDRESS IS ON OUR WEBSITE AND ABOVE.**
