TAXES

- Summer taxes are due on September 15, 2025, without interest after the 15th interest will be added.
- Winter taxes are due on February 16, 2026, without penalty. Please allow 1 week mailing time.
- If you did <u>NOT</u> mail your tax payments by SEPTEMBER 15, 2025, please call the TREASURER for updated tax amounts. You can pay in person on the final due dates at the Township Hall on the following dates:

September 15, 2025 · December 26, 2025 · February 16, 2026 · March 2, 2026

- You can now pay by credit card online at our web site. There is a usage fee of 2.30% not less than \$1.50. You must allow 5 days for processing of your credit card payment. They are NOT done and deposited the same day. For more information, please go to our website at www.UnionTownshipgt.com.
- WINTER TAXES <u>must be in the Treasurer's hand for the February 16, 2026, and March 2, 2026, payments.</u>
 <u>POSTMARK'S WILL NO LONGER BE HONORED FOR THE FEBRUARY DATES.</u> If these dates change, there will be a posting at the hall, or you can call 231-492-9855 to verify the dates.
- Unpaid taxes will be turned over to the Grand Traverse County Treasurer as DELINQUENT on March 3, 2026. At that time, will need to call the Grand Traverse County Treasurer for updated amounts due. <u>ALL CHECKS MUST BE MADE OUT TO GRAND TRAVERSE COUNTY TREASURER AFTER THE DATE OF March 2, 2026</u> AS THEY CAN NO LONGER ACCECPT CHECKS MADE OUT TO UNION TOWNSHIP.
- If you are a <u>disabled veteran</u> and qualify for the veteran's exemption, the form is on our website. <u>This form MUST BE COMPLETED AND MAILED TO THE ASSESSOR.</u> <u>THE ASSESSOR'S MAILING ADDRESS IS ON OUR WEBSITE AND ABOVE.</u>
