



**ARTICLES OF INCORPORATION  
OF  
GREATER CINCINNATI RECOVERY RESOURCE COLLABORATIVE, INC.**

**ARTICLE I**

The name of said corporation shall be Greater Cincinnati Recovery Resource Collaborative, Inc.

**ARTICLE II**

The specific purpose for which the corporation is formed is to provide support, education, and counseling for individuals who are recovering from alcohol or drug addiction in a home-like atmosphere. In furtherance of that or any charitable, religious, educational and scientific purposes, the corporation is authorized to exercise any, all and every power which a non-profit corporation organized under Chapter 1702 {ORC 1702.01} of the Ohio Revised Code for charitable, religious, educational and scientific purposes can be authorized to exercise, but not any other power.

**ARTICLE III**

The duration of the corporation shall be perpetual unless sooner dissolved by operation of law.

**ARTICLE IV**

The corporation shall be governed by a Board of Directors, the number, qualifications, and terms of which shall be set forth in the By-Laws of the corporation.

#### ARTICLE V


No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### ARTICLE VI

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, and to such organization or organizations organized and operated exclusively for charitable, education, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, or its then counterpart, as the Board of Directors shall determine.

**ARTICLE VII**

The street address of the corporation's initial registered office in Ohio is 508 Elberon Ave. Cincinnati, OH.  
45205 and the name of the initial registered agent at that office is Barry L. Monroe.
