A--Guidelines for use of GLP 1 Receptor Analogues--

- 1. To be used only in patients of Type 2 Diabetes Mellitus as an add on, who are not achieving desired HbA1c levels despite use of conventional therapy/basal insulin
- 2. BMI more than 35 Kg/metre square where avoidance of hypoglycemia and weight gain is of primary concern
- 3. Patient has established cardiovascular disease
- 4. Prescription to be signed by HOD Medicine/Endocrinology of a Government Hospital
- 5. Contraindications such as pancreatitis, Multiple Endocrine Neoplasia Syndromes, C Cell tumours, severe Inflammatory Bowel Disease have been ruled out. B-- Guidelines for use of insulin Ryzodeg--
- 1. Inability to achieve desired glycemic control despite use of multiple subcutaneous insulin therapy such as use of rapid insulin in combination with basal insulin, thrice daily injections of pre mixed insulins.
- 2. Out of range Self monitoring blood glucose results and HbA1c reports
- 3. Presence of conditions which require a tight glycemic control.
- 4. Prescription to be signed by HOD Medicine/ Endocrinology of a Government Hospital.
