New Business



 Antonio Lucero motions for the Council to purchase 6 tables to be used by CHEC, 3 at 6 feet, 3 at 8 feet. Second by Cesar Espinoza.
 - Discussion began, which some Knights were offering to bring their tables to help the event.
 - Discussion also included if purchased to add "K of C" or "Knights of Columbus" under the tables to also be used by Council as needed.
 - Called to vote, passed
- Chris Lubahn verified some Knights that should be removed.
- Sisters of Life, supported by Knights worldwide. Sisters need assistance to print items in English and Spanish. Asking \$2,500, DD may be reaching out to each Council to see if can meet the request. Jim Leonard motions to donate \$250, Cesar Espinoza second. Pat Costello offers amendment to make the amount \$500. Cesar Espinoza and Jim Leonard accepts the amendment. Motion passes and will be taken from the Clay Shoot funds.
