• Unfinished Business was taken up and disposed of as follows:

- Vest orders (Antonio Ledezma) reordered with correct lettering and logo, have arrived
- Form 990 Status? Antonio Ledezma indicated more info to still be provided
- Semi-Annual audit is past due. Trustees are completing
- Christmas tree is purchased
- We have a motion by Antonio Lucero and a second by Cesar Espinoza to pay a special assessment of up to \$18,500 from the bingo account to the Columbian Home to pay for floor repairs. Floor repairs to include wood floor and the linoleum around the wood floor. After discussing whether or not a special assessment is a legitimate Fraternal expense, discussion about Columbian Home (Landlord) billing Council (renters) similar to other consistent renter charged special assessment for parking lot. Potential scrutiny if approved, as not charitable, but would need to verified as a fraternal matter. Discussion involved inability to serve community without a place to hold our charitable work. Called for vote, 5 opposed, motion passed.

New Business

- Christmas checks for priests? From bingo account? Clarified that is in budget, and so priests will be given \$500 each as a Christmas gift
- Breakfasts for January through March Weekday Masses will be in the PLC from January through March. Not sure whether or not we will be able to have breakfasts during those months in the PLC. Waiting to hear from Fr. Julio.
- Dinner with priest St. Augustine is replacing the operating portion of the HVAC system. Expected to cost \$80,000. Fr. Julio asked the Council to host a dinner to raise \$10,000 on Fat Tuesday. He is open to another date if we believe Fat Tuesday is not a good day. \$10,000 may be too much of a stretch as we filled the PLC last time and only raised \$5,000. Ken will speak to Fr. Julio.
